Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act- 2007 to the effect that Santosh Mahato (User) W.M. by passing electricity unlawfully i.e. bypassing of energy meter i.e. tampering of service connection cable and due to this reason he has committed theft of electricity U/s 135(1)(b) of the electricity (Amendment act- 2007) on 10/06/19 at 14-04 hrs. Entered the premises of Santosh Mahato (User) Vill. Amdihra P.S. Purulia (T), Dist- Purulia, having Consumer No. 242023811, Meter No. L15.29A2 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan - 0.8 nos.
- 2) CFL - 06 nos.
- 3) Water pump - 08 nos.
- 4) TV - 04 nos.

Out of which I seized the following

- 1) PVC 2 core Service Connection Cable alongwith bypassing arrangement - 02 ft (approx).

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 14:24 hrs. on 10/06/19. The accused person has committed an offence U/S135(1)(b) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
