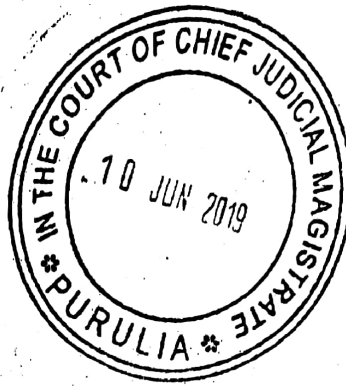

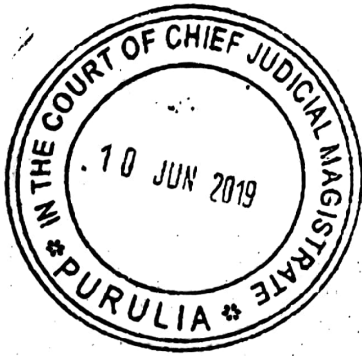

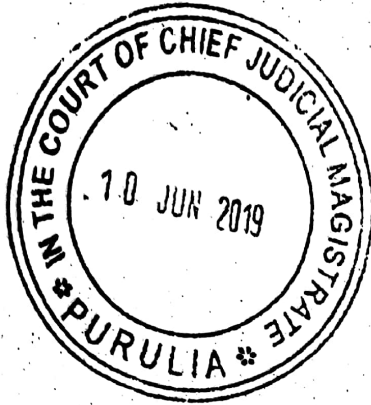
The humble petition on behalf of the Complainant ;

Most Respectfully Sheweth :-

1. That, your Complainant is the legally married wife of the accused, Sindhu Dey, son of Late Jiban Dey of Dipupara, Asansol, Palas Bagan, Asansol North P.S. ,Dist. Paschim Burdwan, West Bengal and the marriage was registered at Purulia on 6.07.2004. After marriage they were living at Asansol and blessed with two sons and one daughter, their age are 13 years, 11 years and 5 years respectively.

2. That, after two years of marriage your complainant was happy but after that the husband of your complainant put pressure upon your complainant to bring Rs.50,000/- (Fifty thousand) from her father's house ,but they expressed their inability to fulfil the absurd and illegal demand of the Accd/husband and since then the accused started all sorts of inhuman physical and as well as mental torture upon your complainant - stopped food and clothings inspite of that your

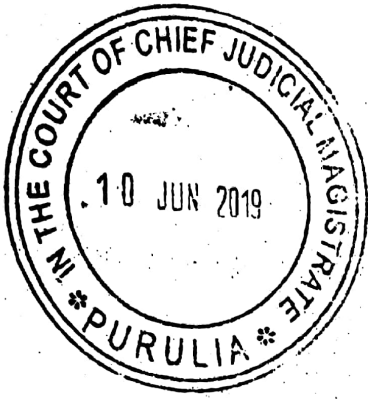
Complainant adjusted but persistently torture and assault increased day by day and it became un-tolerate to her and in the meantime the husband of your complainant established illicit relation with two/three women and the phone record is with your complainant. The complainant objected to it but of no good.

3. ___ That, on 3.3.2019 the accused at 7 a.m. assaulted your complainant mercilessly and took an ^{attempt} ~~attempt~~ to kill ~~murder~~ her by pouring Kerosene oil but due to the intervention of the children and the neighbours the life of the complainant was saved and complainant was compelled to come to Purulia .

4. ___ That, again on 7.3.19, the accused came to the father's house of your complainant at Purulia with some anti-socials and assaulted her then the neighbours raised alarm and those persons fled away from the house of your complainant from Purulia.

5. ___ That, your complainant informed the matter to the local P.S. as well as the Superintendent of Police, Purulia who advised her to take shelter before the Court of law.
