As information received from the Representative of M/s Ranjit Nandy who is engaged in LT Line Maintenance under Saltore Customer Care Center that they have physically assaulted near hanuman mandir of village Ghutitora while they were came back after completed their work at village simulia for service call on dated 31.05.2019 at about 18:30 Hrs. Near the hanuman mandir of village Ghutitora some people block the main road and collecting money, when our representative requested to leave them One of them Sri Mejha Bauri, S/o- Sri Kartik Bauri of Vill-Ghutitora throwing slang language to our representative and physically assaulted to Sri Manik Mahato. The original submission by representative of M/S-Ranjit Nandy has been attached herewith which will speak to itself.

It is requested to investigate the case in detail and help us to provide uninterrupted service on behalf of WSEDCL.

As I was badly engaged in other works so delay was caused to lodge this complaint.
