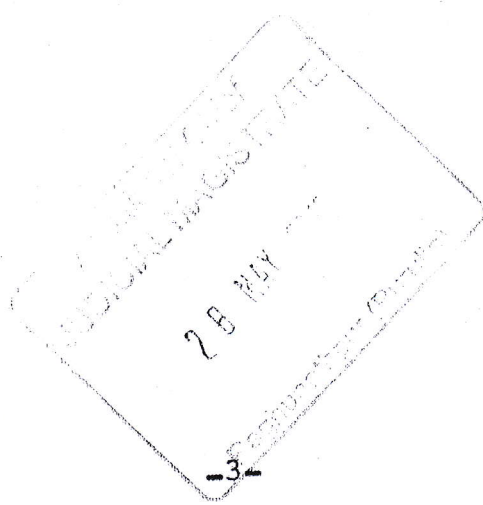

2. That on the day of incident at relevant point of time while your complt. was at her home all the acceds. persons in order to take revenge of previous grudge all on a sudden entered into the house at the complt. having armed with weapon with a view to materialise their common intention to cause greivous hurt on the person of the complt. ~~Acced~~ namely Bachhu Sikdar was havin armed with large size vegetable cutter. Ganesh had iron rod in his hand and Barsha was armed with lathi. Anna Sikdar was encouraging other acced. persons as soon all of them entered into the house of the complt.

3. That all the acced. persons grew furious in red teeth and claims and started abusing the complt. with filthy language
 " *কালী সুবিশুদ্ধ কোথায় গেলি তোকে ভাজে উঠবে যত্ন করে দেব, কেউ বাঁচবে পারবে না* //"
 "Hearing such threat ^{Acced persons no 2 & 3} wife of the complt. and complt. himself raised protest in which acced. persons shouted to the witness no 2 calling as "witch" due to sudden demise of her own son. Acced. persons also gave threat to drive out the complt. from his house with their muscle power without any care of law of the land.

4. That during such episode while acced. persons tried to assault the complt. with the weapons complt. and his wife anyhow ^{with the help of witness no 3.} saved themselves from the clutches of the acced. persons and cried for help and many of neighbourers have witnessed the same but none come forward due to notorioucity of the acced persons

5. That on the same day your complt. had been to Raghunathpur P with written complaint against the acced. persons for his remedy but official advised him to come later. However no action was taken by the concerning P.S. as such finding no other alternate complt. sent his grievance to the S.P. Purulia through Regd. post on 03-04-19, but no action has yet been taken against the acced. persons. Hence complt. seeks his remedy before the Id. courts.

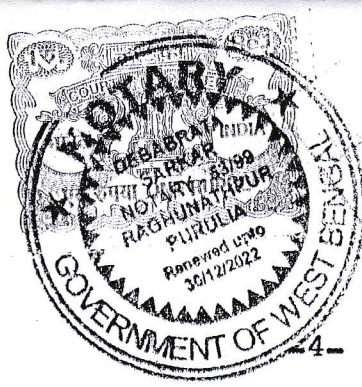
