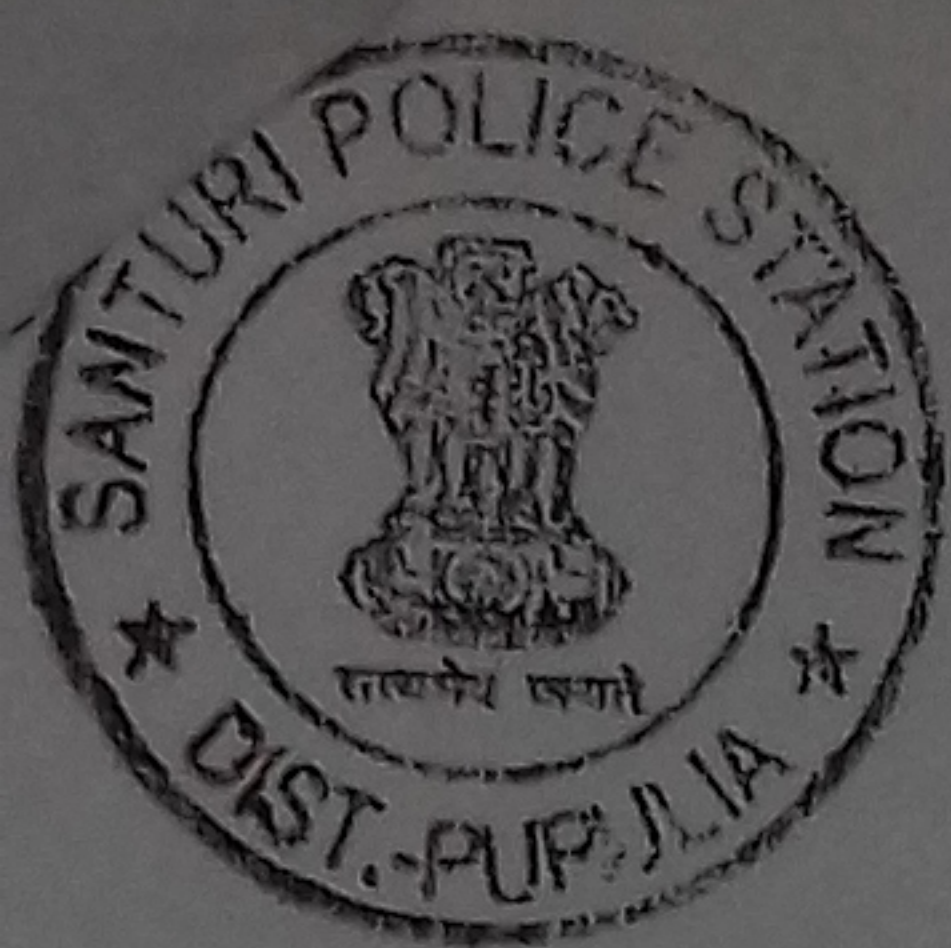

Respected Sir,

I ASI Biswarup Roy (DOB 08.04.1973) S/O Sri Jitendra Nath Roy of village Bahadurpur, P.S Jamuria, Dist. Paschim Burdwan now posted at your P.S in producing here with the arrested accused person namely Debasish Mondal (42) S/O – Dilip Mondal of Vill + PS - Santuri, Dist - Purulia along with 37 (thirty seven) liters 200 (Two hundred) ml. Country Spirit (62 bottle X 600ml) (Rs- 35 X 62= 2,170/-) seized under proper seizure list, I beg to submit that today I along with force while performing evening mobile duty at about 20:25 hrs received a credible source information that one person namely Debasish Mondal (42) S/O – Dilip Mondal of Vill + PS - Santuri, Dist - Purulia is stocking and selling Country Spirit without any valid license from his dwelling house at Santuri village , P.S - Santuri, Dist - Purulia. Accordingly, I along with force had been to the spot at Santuri village to work out the source information and held raid into the premises of above mentioned accused person. When we reached near to the dwelling house of him then seeing the Police personnel, customers were fled away. During search with the help of my accompanying force, we found that the said person is stocking Country Spirit bottles for sale. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 and supply one copy to him. Then, I seized and labeled 62 (Sixty two) bottle "DIL SE" country spirit containing 600ml each bottle and amounting Rs-35/- (Thirty five) each bottle, Total amounting Rs-2,170/- under proper seizure list duly signed by the witnesses. From the seized bottles one bottle is sealed and labeled as sample.

Under the above circumstances and fact, I therefore pray that a cog. case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Debasish Mondal (42) S/O – Dilip Mondal of Vill + PS - Santuri, Dist - Purulia and arrange for its investigation.
