- 2) Ten pieces of plastic glasses.
- 3) Sale proceed Rs/-65

I ASI Parimal Tewary of Adra PS do here by lodged a complaint against accused namely Narahari Bouri (33 Yrs) S/O Lt. Binod Bouri of Vill- Dalandanga, PS-Adra, Dist- Purulia to the effect that on 06/07/19 at about 16:35 hrs in course of my evening mobile duty I received a telephonic information from a reliable source that one Narahari Bouri was stocked of country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per his direction I along with force. At about 17:35 hrs. reached at Dalandanga village and hold raid in the grocery shop of Narahari Bouri found that said of Narahari Bouri selling liquor at his house and seeing the Police party some person fled away and said of Narahari Bouri to concealed himself but I able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accused Narahari Bouri (33 Yrs) S/O Lt. Binod Bouri of Vill- Dalandanga, PS-Adra, Dist- Purulia and arrange for its investigation.
