
Most respectfully begs to state:-


1. That the Complainant is presently residing at her father's house situated at Vill-Shaludahar, P.O- Hensla, P.S- Arsha, Dist. – Purulia, within the Jurisdiction of this Ld. Court.





- 2. That the complainest is the legally morned wife of Sri Bikash Chandra Sabia, Svi-Late Bissed Sabia, a resident of Vill + P.O. Blud, P.S. Arsha, Dist. Purulia, and their marriage is still subsisting.
- 3. That the marriage negotiation was held at the parent's house of the complainant and the marriage was solomnized on 12/03/2011 at the father's house of the complainant as per the Hindu Rights and customs prevail in their society.
- 4. That at the time of marriage the father of the complainment had to give a sum of Rx. 80,0005- cash, one motor cycle, gold ornaments, familtares, utensits, clothes, etc as you the domaind made by the socused persons i.e all the accused persons as downy, so domained by them.
- 5. That after completion of the marriage the complainant was taken to her matrimonial home and started their matrimonial life with full hope.
- 6. That from the inception of marriage the complainant was never accepted with love and dignity and she was often teased by her husband namely and his family members i.e all the accused persons on the score that the downy given at the time of marriage were inadequate and below quality and started to inflict torture the complainant on both way i.e physically and mentally on demand of further additional downy.
- 7. That the complainant used to tell her parents for the demand of further additional downy made by the accused persons and sometimes in order maintain peace and hurmony in the matrimiceial home, the father of the complainant used to give 10,000/- 20,000/- time to time, but the accused persons were not at all satisfied with such sum, and asked the complainant to bring a sum of Rs. 1,00,000/- from her father as additional downy and when the complainant express the inability of her father, all the accused persons assaulted the complainant in a brutal manner by fist and blow.
- 8. That the complainant had to swallow all such torture and mental pain with the hope that with the passes of time her husband will be changed and happy days will come again and her immates gave consolation that situation would improve but all the hope was in vain. That during passage of time the complainant gave birth of three





daughters and one sons who are now aged about 6 years, 5 years, 3 and half years and one and half years respectively.

- 9. That after birth of the fourth daughter, the torture made by the accused persons upon the complainant was at extreme end, she including her children were never provided with proper food and clothes, even they were always neglected with any sort of medical treatment. The accused persons often used to tell the complainant that "Tin tin ta meyer jonmo diyechis, oder khoroch ki tor baap debe?" and often used to assault the complainant in a routine manner and used to give pressure to left the matrimonial home.
- 10. That on 25.04.2019, all the accused person pressurized the complainant to bring a sum of Rs. 1,00,000/- from her father and also pressurized to make arrangement for marriage of the brother of the complainant with the accused person No. 6 namely Kono sahis, and when the complainant protested the same, she was badly assaulted by all the accused person and driven out from the matrimonial home along with her children and at present the complainant and her children are residing with her father.
- 11. That after driven out and after came back to the parent's house, the complainant had been to Arsha P.S and informed the matter and lodged the complaint but the police of Arsha P.S. refused to accept the same, the reason is best known to them.
- 12. That seeing no action on the part of police personal of Arsha P.S, the complainant send a written complainant to the officer-in-charge, Arsha P.S through registered post on 31.05.2019 and subsequently informed the matter to S.P, Purulia on 06/06/2019 but no action has been taken.
- 13. That the police authority directed your petitioner / complainant, orally to come through this Ld. Court hence this petition U/s- 156(3) Cr. P.C.
