



The above named Complainant begs to state as under :-


1----That the petitioner is the legally married wife of Accused Shraban Mahato . The parties are Kurmi Mahato by caste and Hindu by religion . Their marriage was solemnised on 10-05-2017, according to their customary rites prevalent in their community . Their marriage was duly consummated and the marriage tie is in subsists .

2----That at the time of my marriage, as per demand of accused Shraban Mahato and his father and others father of the petitioner had to give a considerable dowry including a hard cash of Rs. 100,000/- ornaments utensils and furniture etc. to the accused persons but but they were not satisfied with the same.

3----That after marriage, the petitioner had been to her matrimonial home and started to live as husband and wife with accused Shraban Mahato . From the very inception of her stepping in the matrimonial home, her husband in collusion with the other accused persons namely Nirodh Mahato and Fudun Mahato (parent in law ) Hemani Mahato and Pari Mahato (Sister in law )jointly started to torture her mentally and physically regarding the insufficient dowry and tease her which is beyond description . All the accused persons started a fresh demand of Rs. 50,000/- or a two wheeler from her father and asked her to bring the same otherwise she would have no place in their house they threatened but her poor father could not able to meet the fresh demand .

4----That when the money as demanded by the accused persons could not be meet by her poor father, at this, all the accused persons became furious and vindictive towards her and all the accused persons openly spoke out that they would taught her a good lesson and started various mental and physical torture, harassment, assault and cruelty upon the petitioner on various false






abetment and instigation of accused Binod Mahato S/O late Ram Mahato , Fudun Mahato W/O Sri Binod Mahato ,Hemani Mahato and Pari Mahato daughters of Binod Mahato and Nirmal Mahato S/O Suku Mahato , Though the petitioner had no fault whatsoever she was not spared from the mental torture and physical oppression by the hands of the accused persons . Her husband, mother in law and sisters in laws stop her square meal and denied bare necessities of life and forced her to do all the domestic work alone like a unpaid maid servant .

5----That during her stay in the matrimonial home, she detected that her husband has developed illicit relation with a lady namely Debi Kumhar. In every night her husband brought Debi Kumhar in his bed room and passed night with her and compelled the petitioner to pass night in the open Varanda. When the petitioner protested against the immoral and heinous act of her husband in that event, each and every occasion she was silenced with severe assault by her husband and other accused persons and threatened the petitioner with dire consequences.

6----That being a devoted Hindu wife , the petitioner patiently bear those mental and physical torture assault , cruelty and harassment on the hope that her husband and others accused persons would mend themselves and to be normal towards her in near future but her hope was never materialised and became shattered .Day by day mental torture and physical oppression gradually intensified upon the petitioner by the accused persons which is beyond description and unbearable





7----That over the issue of Debi Kumhar, there was frequent altercation and ivot exchange of words was going on between the petitioner on one side and the accused persons on the other. The petitioner politely requested Debi Kumhar not to spoil her marital relation and to leave the company of her husband but she was so adamant in her attitude that she shamelessly asked the petitioner to go to her paternal home and commit suicide there. Later on it so happened that her husband and Debi Kumhar jointly started to inflict torture and assault the petitioner without any fault. The petitioner strongly apprehend that the accused persons and Debi Kumhar would kill her by administering poison.

8----That on 3<sup>rd</sup>. April 2019, over the issue of Debi Kumhar all the accused persons drove out the petitioner from her matrimonial house after severe assault. Two days after, father of the petitioner reached the petitioner to her matrimonial home but she was not allowed to enter the house by the accused persons and she come back with her father to her paternal house and constrained to took shelter in her father's house at Village Saridih , under P.S. Baghmundi, District Purulia (W.B.). The accused persons hurled continuous abuses and threats to the petitioner over Telephone on several occasion and asked her to commit suicide in her paternal home.

9----That the reported all the ordeal faced by her in the matrimonial home to the O/C Baghmundi Police Station in writing but the O/C concerned did not started any specific case against the accused persons best known to him . Finding no other alternative , your petitioner knocked the door of the Superintendant of Police Purulia on 06 -06-2019 , with a request to take legal measure against the accused persons but nothing has been done by his good self. .

10----That your petitioner is a deserted, destitute, vagrant and helpless lady having no source of income. She is in acute distress and poverty. She has no capacity to pull and conduct the case on her own cost. Moreover, there are some legal and technical aspects involved in this case which requires
