Sir,

With due respect and humble submission, I do hereby lodge a written complaint against 1) Sridam Hembram S/o Lecha Hembram 2) Thakurdas Hembram 3) Anil Hembram 4) Samutul Hembram 5) Gokul Tudu S/o Lt Lathey Tudu all are of vill-Amru Hamsa, P.S. Balarampur Dist-Purulia along with 100/150 unknown supporters of Amru Hansa Jiban Jibika O Paribesh Rakha Committee to the effect that today on 02.07.19 I, ASI Abu Akher along with other force engaged in performing anticrime Day Mobile duty at P.S. area vide Balarampur PS CC No-2546 and GDE No-57 Date: 02.07.19. At about 08:35 Hrs received a information from on duty officer of Balarampur P.S. that about 100/150 unknown supporters of Amru Hansa Jiban Jibika O Paribesh Rakha Committee being armed with deadly weapons like lathi, tangi, axe etc blocked the Purulia – Balarampur pitch road (NH32) near Amruhansa Bridge by placing wooden block and stones that leads impassable condition of the travellers and started to raise slogans regarding their various demands.

After a prolong waiting I have tried to pursue the agitators to withdraw the blockade and help police to disperse the mob as well as discharge lawful duty. It was also found more than 120/130 vehicles loaded with goods and loaded with passengers and drivers including patients etc. from Purulia Side and Balarampur side were detained there and subjected to enormous sufferings for a long time. The above accused persons continued to be with the unlawful assembly, causing unlawful restraint to the vehicles & passerby and thus generated danger & obstruction in National highway and also caused obstruction to police in discharging Govt. duty. in spite of several time persuasion, they did not pay any heed.

At about 15:05 hrs, I along with BDO office staffs again tried to pursue the agitator to withdraw the blockade. At about 15:15 hrs the road blockade was withdrawn after getting the assurance of SDO (S) East and BDO Balarampur.
