Respected Sir,

In producing here with one arrested accused person namely Dasharath Karmakar (51 yrs) S/O- Lt. Brindaban Karmakar of Vill.- Berma, P.S.-Balarampur, Dist.- Purulia along with seized 14 (fourteen) sealed country sprit bottles (DIL SE) Each Bottle 600 ML (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 20:05 hrs. I received a credible source information that one Dasharath Karmakar S/O- Lt. Brindaban Karmakar of Vill.- Berma, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own house at Berma under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Berma village to work out the source information. Thereafter we reached at Berma at about 20:25 hrs as per source information and held raid in the house of Dasharath Karmakar.

During search with the help of accompany force, we found that the said person is selling country sprit bottles (DIL SE) in his home. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country sprit. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 14 (fourteen) sealed country sprit bottles (DIL SE) Each Bottle 600 ML and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Dasharath Karmakar S/O- Lt. Brindaban Karmakar of Vill.- Berma, P.S.- Balarampur, Dist.- Purulia and arrange for its investigation.
