Most humble I Smt.Suman Barnwal w/o Gopal
Shaw and D/o Binod Kumar Barnwal, resident of Balarampur, P.O.Rangadih, P.S.Balarampur, Dist.Purulia, beg
to state for your kind consideration and passing necessary order for the following;

- 1. That I, Smt.Suman Barnwal was married to Gopal Shaw on 14.03.2018 according to Hindu rites and customs prevailing in our community.
- 2. That after the said marriage. I was taken to my matrimonial house at Balarampur, P.S.Balarampur Dist.Purulia and started living therein as wife and husband.
- 3. That in my matrimonial house my husband Gopal Shaw physically and mentally assaulted and/or tortured me by fists and blows and insulted me after taking liquor on the night and also demanded Rs.50,000/-as further dowry from my father.
- 4. That there was several reconciliation between us, but my husband did not tried to adjust and lead a happy conjugal life.

As such I had to file a matrimonial suit being Mat Suit No.55/19 against my husband u/s.27 of the Spl. Marriage Act, 1954 before Judge Court, Purulia.

- 5. That my husband Gopal Shaw is committing cyber crime and sending absence photos and offencsive massage to me and others through electronics median and/or through Internet/Communication media and/or Online on 15.2.19, 16.2.19, 21.2.19, 28.2.19, 2.3.19, 4.3.19, 5.3.19, 6.3.19, 9.3.19, 10.3.19, 12.3.19, 13.3.19, 14.3.19, 15.3.19, 16.3.19, 19.3.19, 10.4.19, 4.5.19, 9.5.19, 18.5.19, 21.5.19, 27.5.19 and 14.6.19 sanding such offensive massage and/or absence through phone/electronics media canses insult, Injury, criminal intimidation's enmity, hatred and ill will to me and/or to this complainant.
- 6. That such type of offensive message send by my husband Gopal Shaw causing annoyance, in convenience, danger, obstruction insult, injury, criminal Intimidation and my prestige has been lower down in the society.
- 7. That my husband has comes such type of cyber crime on the hatred and enmity.

Under such facts and circumstances my civil rights of individuals/myself has been curtle and huge amount of obsence materials circulated in the internate comes my insult, criminal intimidation,

injury and hatred before the society and harms my prestige.

It is the refore prayed that the accused Gopal Shaw should be arrested immidiately for causing cyber crime against me, and be pleased to punished him accordingly to law.
