Respected Sir,

In producing here with one arrested accused person namely Bhairab Mondal (38 yrs) S/O- Jaladhar Mondal of Vill.-Baraurma, P.S.- Balarampur, Dist. Purulia along with seized i) 13 (thirteen) sealed country sprit bottles (DIL KUSH) Each Bottle 600 ML, ii) 4 (four) Plastic empty bottle, iii) Plastic Glass 08 Pcs. (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 16:50 hrs. I received a credible source information that one Bhairab Mondal S/O-Jaladhar Mondal of Vill.-Baraurma, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own house at Baraurma under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Baraurma village to work out the source information. Thereafter we reached at Baraurma at about 17:35 hrs as per source information and held raid in the house of Bhairab Mondal.

During search with the help of accompany force, we found that the said person is selling country sprit bottles (DIL KUSH) in his home. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country sprit. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total i) 13 (thirteen) sealed country sprit bottles (DIL KUSH) Each Bottle 600 ML, ii) 4 (four) Plastic empty bottle, iii) Plastic Glass 08 Pcs. and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Bhairab Mondal S/O- Jaladhar Mondal of Vill.-Baraurma, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
