Sir,

In producing herewith arrested accused Sudhir Ch. Mandal (57 yrs) S/O- Lt. Sashibhusan Mandal of Vill.- Ghatbera, P.O.- Ghatbera, P.S. - Balarampur, Dist - Purulia and brought under seizure

1) One improvised iron made, country made pipe gun having total length about 10 1/2 ", having wooden Butt length about 4 1/2", having barrel length about 5.11", having trigger, firing pin, 2) 02 (two) live ammunition (8 MM) in unloaded condition from his pocket, under proper seizure list duly signed by the witnesses as well as accused person. I do hereby lodge a complaint to the effect that in course of evening mobile duty at 20:05 hrs. I received a information from my source that 01 (one) person of Ghatbera village under Balarampur P.S Dist-Purulia got a contract for supplying arms & ammunition, and in this regard he will pass through near Khekridih Primary School More along with some arms & ammunition to supply the same on 25.07.19. Accordingly, I informed the matter to O/C Balarampur P.S. and as per direction of O/C Balarampur PS myself along with accompanied force along with source reached near Khekridih Primary School and kept the vehicle in a safe distance and proceeded towards the Khekridih Primary School More on foot and ambushed. At about 22:15 hrs, we found 01 (one) person coming from Ghatbera village side on pitch road. We intercepted him at Khekridih Primary School more. On being asked he disclosed his identity as Sudhir Ch. Mandal S/O- Lt. Sashibhusan Mandal of Vill.- Ghatbera P.O.- Ghatbera, P.S. - Balarampur, Dist - Purulia. On through search on his person, we found 01 (one) improvised iron made pipe gun, having iron but trigger, firing pin found from his waist along with 02 live ammunition (8 MM) from his pocket . On being asked he failed to produce any valid license or authority for the said arms & ammunition which is found from his possession or which arms & ammunition he was carrying. So, I seized the said arms & ammunition under proper seizure list duly signed by the witnesses as well as arrested him monitoring all the guide lines regarding arrest. No public witnesses could be available there.

Under the above fact and circumstances, I, therefore, pray before you to start a specific case under proper section of law against Sudhir Ch. Mandal S/O- Lt. Sashibhusan Mandal of Vill.- Ghatbera P.O.- Ghatbera, P.S. - Balarampur, Dist - Purulia and obliged.
