This is to inform you that today at around 6 AM a Raid Programme has been conducted jointly with Barabazar PS permission by the order of SDL & LRO, Manabazar, Purulia, vide memo no COA/11/SDL & LRO/Man/19 dated 03/07/19

During the Raid Programme when we were moving jointly, near Sargo village on Manabazar - Barabazar Road to intercept on tractor having registration no WB 55A 4668 loaded with unauthorised sand, tried to flee away. Eventually we chased the said vehicle and intercept the same in a short distance at Sargo. The driver of the said vehicle unloaded the tray of the tractor with a plan to flee away. When we intercepted the said vehicle and tried to initiate the legal process then owner of the tractor and his two sons started pelting stone towards the our Raid team, during of this our Raid engaged vehicle's i.e. WB 55A 4837 back and front winds screen.

were totally damaged. and also at the said time they have applied criminal force to deter the Raid team from execution of their legal duty. As such we and my team fail to discharge the duty. On duty police team rescued the Raid party and we came back to our office

Late we came to know that the owner of the tractor named; Janaram Mondal and his two sons Lotan Mondal & Pallan Mondal. They deter the public servant from discharging of their duty.
