I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Mahabir Majhi, S/O LT. Banerwar Majhi of Vill- Tuima Tola Baradih, P.S- Barabazar, Dist- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of single core PVC wire and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 24.07.2019, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 05:09 P.M., entered into the premises of Mahabir Majhi, S/O LT. Banerwar Majhi of Vill- Tuima Tola Baradih, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill.- KAZIDIH, PANCHUKUDA, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Mahabir Majhi, S/O LT. Banerwar Majhi of Vill- Tuima Tola Baradih, P.S- Barabazar, Dist.- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of 2-core flexible wire in his premises at Tuima Tola Baradih having connected load 0.071 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no of bulb (60 Watt).
02. 01 no 2-core flexible wire (8 Mtr. App.) along with hooking device.

Out of which I seized the following articles:

01. 01 no of bulb (60 Watt).
02. 01 no PVC flexible wire (8 Mtr. App.) along with hooking device.


Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 05:31 p.m.
