Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Jalil Ansary, S/O Sk. Yousuf Ansary of Vill- Basudebpur, P.S- Barabazar, Dist- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of single core PVC wire and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 24.07.2019, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 06:08 P.M., entered into the premises of Jalil Ansary, S/O Sk. Yousuf Ansary of Vill- Basudebpur, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill.- KAZIDIH, PANCHUKUDA, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Jalil Ansary, S/O Sk. Yousuf Ansary of Vill- Basudebpur, P.S- Barabazar, Dist.- Purulia, his family was enjoying electricity illegally hooking from nearest LT OH line with the help of 2-core flexible wire in his premises at Basudebpur having connected load 0.118 KVA.

From the above arrangement he was using the following arrangements:

01. 01 no of bulb (100 Watt)
02. 01 no PVC flexible wire (5 Mtr. App.) with hooking device.

Out of which I seized the following articles:

01. 01 no 2-core flexible wire (5 Mtr. App.) along with hooking device.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 06:32 p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
