Sir,

In producing here with arrested accused namely Shyamapada Bauri (44 Yrs.) S/o Debu Bauri of Vill- Biralgoria, PO- Batikara, PS- Purulia (M), Dist- Purulia along with seized Country Spirit bottles DILSE (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 06.07.19 at 17.45 hrs received a credible source information I, ASI Tapan Kr. Pandey along with force held raid (18.35 hrs.- 19.05 hrs) in a Sweet Shop of above noted accused person at Deshra More beside under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country sprit which was kept in his Sweet Shop at Deshra More under Hura PS Dist Purulia, On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Accordingly, I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle. Then I arrested him after preparing proper Arrest Memo, maintained all formalities regarding arrest as he committed offence U/S 46A(c) B.E. Act and supplied one copy to him. This is to note here that on seeing police party all public/customers fled away. Total 22 (Twenty two) Plastic bottles DIL SE measuring 600 M.L. each bottles and value Rs- 35/- each bottles have been seized.

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 46A(c) B.E Act may kindly be started against the arrested accused person namely Shyamapada Bauri (44 Yrs.) S/o Debu Bauri of Vill- Biralgoria, PO- Batikara, PS- Purulia (M), Dist- Purulia and arrange for its investigation.
