## To The Officer-in-Charge Hura PS Purulia

I, SI Dhirendra Nath Mandal of DEB, Purulia in producing herewith the arrested accused persons (1) Uttar Ch. Mahato (71 yrs) (owner of the modified ration shop at Nadiha village) s/o Lt. Beni Madhab Mahato of Nadiha, Laxmanpur, PS Hura, Dist Purulia (2) Monotosh Mahato (36 yrs) s/o Uttar Ch. Mahato of Nadiha, Laxmanpur, PS Hura, Dist Purulia & (3) Tapan Mal (21 yrs) (driver of the offending vehicle) s/o Baul Mal at Kulabahal, PS Hura, Dist Purulia alongwith the seized articles approx 180 ltrs. of K. Oil containing in 6 nos. of plastic jerricans loaded with vehicle No. JH10AJ/4175 (ACE van) with proper seizure list do hereby lodged a written complaint with relevant papers to the effect that in pursuance a credible source information being directed by Dy.SP(HQ), Purulia holding Addl. Charge of Dy.SP(DEB), Purulia myself with (1) SI Sajal Mishra (2) JC/427 Sourav Panja all of DEB Purulia reached at Hura PS and noted the fact vide Hura PS GDE No.855 dtd.20.07.19, that one vehicle loaded with K. Oil in jerricans will proceed towards Layekdih More from Nadiha village for selling K. Oil in the open market for clandestine business purpose with a view to earn money by illegal way.

Hence, today at about 05:45 hrs arrived at near Nadiha village beside Aambagan, approx 1 KM from Nadiha village along with the officers and staff of Hura PS and observed some time to work out the received information. After observing some time at about 05:55 hrs found one vehicle bearing No. JH10AJ/4175 was proceeding towards Layekdih More through the village kancha road. I along with accompanied officers and forces managed to detained the vehicle and on searching found the vehicle is loaded with 6 plastic containers loaded with K. Oil as noted above. On asking the driver and other riders of the vehicle disclosed their identity as noted above. On being further asking they failed to supply any satisfactory account in respect of carrying such K. Oil at that time and to where they carrying the same also purpose of carrying of the said K. Oil. So, there is sufficient reason to believe that the above noted accused persons with the connivance of the above MR dealer carrying the same for selling in the open market with a view to earn money by illegal way, depriving the genuine poor ration card holders.

Accordingly, I seized the above noted vehicle loaded with 180 ltrs.(approx) K.Oil in 6 plastic jerricans from their possession with proper seizure list duly signed by the accompanied officers and forces as there was no public witness at that time on that place due to early morning. Arrested the above accused persons after maintaining all legal formalities regarding arrest with an information to all grounds of arrest.

Therefore, I pray kindly start a case under section 7(i)(a)(ii) of E.C. Act X/1955 & 120B IPC for violation of West Bengal Kerosene Control Order 1968. As per order of Dy.SP(HQ), Purulia holding Addl. Charge of Dy.SP(DEB), Purulia, ASI Swapan Chakraborty will investigate the case.
