Sir,

In Producing here with one arrested accd. Person namely Rabi Kalindi (35 yrs) S/O-Lt. Nathu Kalindi of Jhalda Bandhaghat near Hanuman Mandir, Ward No-07, P.S. Jhalda, Dist. Purulia brought under arrest with seized article 36 (Thirty Six) bottles Country sprit (Dil Khush) each containing 600 ml. in which one bottle collected as sample. I do hereby lodged this written complain to the effect that on-21/07/19 at 19:25 hrs. I received telephonic source information that one person selling (Country sprit) at Jhalda Bandhaghat. I inform the matter to I/C Jhalda P.S over Phone. As per his direction myself SI Anjan Kumar Biswas, along with C/497-Ambuj Kr. Mandal, and NVF/778-Samir Kr. Mahato, NVF/937-Abani Kumar, HG/1681-Manmatha Kumar vide C.C No.1829/19 dtd-21/07/19 left for Jhalda Bandhaghat near Hanuman Mandir, Ward No-07 to work out the information. We reached at Jhalda Bandhaghat near Hanuman Mandir, Ward No-07 at about 19:35 Hours and held raid in the house of Rabi Kalindi (35 yrs) S/O-Lt. Nathu Kalindi of Jhalda Bandhaghat near Hanuman Mandir, Ward No-07, P.S. Jhalda, Dist. Purulia, and found that the accused person selling Dil Khush in his premises. On demand he could not produce any valid documents/license in favour of selling the same. Accordingly I seized the 36 (Thirty Six) bottles Country sprit (Dil Khush) each containing 600 ml. in which one bottle collected as sample under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses but found none.

Accordingly I arrested accd. Rabi Kalindi (35 yrs) S/O-Lt. Nathu Kalindi of Jhalda Bandhaghat near Hanuman Mandir, Ward No-07, P.S. Jhalda, Dist. Purulia having maintained all formalities after issuing arrest memo. On integration he confessed that he selling the said Country sprit (Dil Khush) to the villagers in lieu of money. So he committed offence punishable U/S - 46 (A) (c) of B.E. Act. 1909.

On return to P.S. I along with accd. person and all seized articles. Put the accd. Person in the Lock UP after maintaining all formalities and seized articles kept in P.S. Malkhana and I submitted written complaint before I/C Jhalda P.S. to start a case against Rabi Kalindi (35 yrs) S/O-Lt. Nathu Kalindi of Jhalda Bandhaghat near Hanuman Mandir, Ward No-07, P.S. Jhalda, Dist. Purulia under proper section of law.
