Sir,

In producing here with three arrested accused persons namely (i) Bishnu Sing Sardar (31) S/O Debu Sing Sardar of vill- Belyadih, P.S- Kotshila, Dist- Purulia (ii) Sk Anjar (26) S/O Sk Samad of vill- Kantadih (Nich Para), P.S- Jhalda, Dist- Purulia and (iii) Malay Dutta (32) S/O Mayur Dutta of Dom Para, Ward No- 08, P.S- Jhalda, Dist- Purulia brought under seizure the following articles (i) 01 (one) blue colour hand bag loaded with (a) 12 (Twelve) bottles of WINCIREX cough syrup (Chlorpheniramine Maleate & Codeine Phosphate Syrup) of WINGS BIOTECH Company, Batch No- WCRX-1034 Exp date- 11/2020 (b) 10 (Ten) bottles of Bolirex (Chlorpheniramine Maleate & Codeine Phosphate Syrup) of Nucleus, Batch No- 1BHS0371 Exp date-02/2021 (ii) one ash colour motor cycle Bajaj XCD 125 having registration No- JH 05U/3147 having engine No- JAMBPE01989, Chassis No- MD2DSJBZZPWE01559 from the possession of 03 Accd. persons. I do here by lodged a written complaint against the above noted accused persons to the effect that on 20/07/19 at 20:05 hrs during evening mobile duty along with C/386- Shibendu Sinha, C/958- Madhusudan Ojha, NVF/933- Abani Kumar and NVF/39- Lalit Mahato vide C.C. No- 1822/19 at Birsa more under Jhalda P.S received a telephonic information from my source that 03 (three) persons are coming from Tulin side to Jhalda through Purulia Ranchi road with huge quantities of drugs with them by a motor cycle. After received such type of information the matter is conveyed to I/C Jhalda Ps for onward transmission. Then myself along with my accompanying force rushed to near Masina more on Purulia Ranchi road and keep our vehicle in a dark place. We ambushed & wait for few times and at 20:25 hrs we found one motor cycle was coming from Tulin side then we intercepted the vehicle there and also found three persons were in the motor cycle. On being asked they disclosed their identity as noted above. Bishnu Sing Sardar was riding the motor cycle and others two were pillion driver. On being searched from the red colour DIKI of the said motor cycle we found one blue colour hand bag loaded with (a) 12 (Twelve) bottles of WINCIREX cough syrup (Chlorpheniramine Maleate & Codeine Phosphate Syrup) of WINGS BIOTECH Company, Batch No- WCRX-1034 Exp date- 11/2020 (b) 10 (Ten) bottles of Bolirex (Chlorpheniramine Maleate & Codeine Phosphate Syrup) of Nucleus, Batch No- 1BHS0371 Exp date-02/2021. On demand they failed to produce any valid documents/ license in respect of keeping the said drugs. I also demand paper documents of the said motor cycle but they failed to produce. So I seized the same under proper seizure list duly signed by the witnesses as well as the apprehended persons. Take one bottle of WINCIREX cough syrup From 12 bottle and one bottle of Bolirex cough syrup From 10 bottle as sample and also prepared label with seal. Seizure was made in between 20:45 hrs. & 21:15 hrs. I arrested the three accused persons maintaining all formalities of arrest for violating the sec. 27 of drugs & cosmetics Act 1940.

I therefore pray before you to start a case against the above noted arrested three accused persons under proper section of law and arranged for its investigation.
