Sir,

In producing here with one arrested accd. Person namely Chittaranjan Mahato @ Chitta (45) S/O Lt. Lalji Mahato of vill- Lagam, P.S- Silli, Dist- Ranchi (Jharkhand) brought under arrest with seized article one white colour plastic jaricane containing approx 15 ltr. I/D liquor from which one bottle of I/D liquor (Approx 500 ml) collected as sample, I do hereby lodge this written complain to the effect that on-23/07/19 at about 18:25 hrs. in course of my mobile duty I held raid in the hotel Styled as " Subarnarekha hotel" of Chittaranjan Mahato @ Chitta (45) S/O Lt. Lalji Mahato of vill- Lagam, P.S- Silli, Dist- Ranchi (Jharkhand), situated at Barghutua more under Tulin OP, P.S. Jhalda, Dist. Purulia, and found that the accused person selling I/D Liquor in his hotel premises. On demand he could not produce any valid documents/license in favour of selling the same. Accordingly I seized one white colour plastic jaricane containing approx 15 ltr. I/D liquor from which one bottle of I/D liquor (Approx 500 ml) collected as sample under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses but found none.

Accordingly I arrested accd. Chittaranjan Mahato @ Chitta (45) S/O Lt. Lalji Mahato of vill- Lagam, P.S- Silli, Dist- Ranchi (Jharkhand) having maintained all formalities after issuing arrest memo. On integration he confessed that he selling the said I/D liquor to his customers in lieu of money. So he committed offence punishable U/S - 46 (A) (c) of B.E. Act. 1909.

On arrival at Jhalda P.S. I along with accd. person and all seized articles. Put the accd. Person in the Lock UP after maintaining all formalities and seized articles kept in P.S. Malkhana and I submitted written complaint before I/C Jhalda P.S. to start a case against Chittaranjan Mahato @ Chitta (45) S/O Lt. Lalji Mahato of vill- Lagam, P.S- Silli, Dist- Ranchi (Jharkhand) under proper section of law.
