Sub: Regarding lodge of FIR for the murder of my daughter.

Sir,

Most humbly and respectfully I beg to say that I Hari Ram Manjhi, S/O Late Majlu Manjhi, Vill-Dungrigora, P.O - Ghatiyali, P.S- Pindrajora, Dist- Bokaro belongs to very weaker section. On dated 21.03.2019 my daughter Sangita Kumari age 16 went out from home around 03:30pm for some work. At the late evening when she was not returning home we start searching all nearby places but didn't find anywhere. On the next day again in the morning we went for her but what we found herself hanging on a tree with the help of her dupatta near Izari river. This incident took place in half KM away from the village in Nayadih, PO- Sidhi, PS- Jaipur(OP Pundag), Dist- Purulia, West Bengal. My daughter was upset from some days, when we asked for the reason she explains everything that a boy named Sandip Kumar Hansda, S/o Late Chote Lal Hansda, Vill- Dungrigora, PO- Ghatiyali, PS- Pindrajora, Dist-Bokaro, Jharkhand from the same village use to threaten her each and every time from a long time and ask her to love him and forcefully make physical relationship with her whenever she was alone. So many times she went against it but he warn me that he will degrade me in the public and ruin my entire life. So many time we tried to explain away that leave her alone and don't threaten her anymore but he never understood and day by day he increases his shits. Then whenever he find herself loney he forcefully make physical relation with her evertime. And due to this she was terrified and groped. Sandip use to ask her if she will not make physical relation with him then he will kill her throw away. Due to this she was living under stress for so long. All the incident through which Sangita suffers was written in her copy by herself. The copy of the same for inspection is attached with this application. My claim and full faith is that Sandip Kumar Hansda, S/o Late Chote Lal Hansda, Vill- Dungrigora, PO-Ghatiyali, PS- Pindrajora, Dist- Bokaro, Jharkhand has murdered my daughter and hanged her with her dupatta on tree so that no one can doubt on him. Sandip trailed after my daughter from many days.

This incident was previously informed to the Police Incharge, Pindrajora Police Station, Bokaro, Jharkhand and the Police Incharge of Pindrajora registered this as FIR on 22.03.2019 as Case No. 00/2019. Through Pindrajora Police Station, Bokaro, Due to jurisdiction, zero FIR was sent so I am informing today itself. My claim and faith is that my educated daughter is murdered in a planned way in spotless manner and the she is hanged on a plum tree with the help of her dupatta by him.

It is therefore requested to kindly take legal action against Sandip Kumar Hansda, S/o Late Chote Lal Hansda, Vill- Dungrigora, PO- Ghatiyali, PS- Pindrajora, Dist- Bokaro, Jharkhand be given rigorous punishment by registering FIR so that in future such action could not take place and bring justice for me. For this I shall be eternally grateful to you.
