I ASI Surendranath Saren of Baglata I/C under Joypur PS do here by lodged a complaint against accd. namely - Santosh Kewat (28yrs) S/O Amrit Kewat of Vill-Jeladih, PO- Sidhi, Ps- Joypur, Dist- Purulia to the effect that on 19.07.19 at about 19.15 hrs. in course of my evening mobile duty he received a telephonic information from a reliable source that one Santosh Kewat was stocked of country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Baglata I/C under Joypur PS and as per his direction I ASI Surendranath Saren along with force. At about 19.45 hrs he along with force reached Jeladih more and hold raid in the counter of him and found that said of - Santosh Kewat S/O Amrit Kewat of Vill-Jeladih, Ps- Joypur, stocked liquor at his own Conter/shop and seeing the police party some person fled away and said of - Santosh Kewat to concealed himself but I able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same, So he seized 1) 10 (in sealed condition) DIL SE 80 up country spirit, 600-ml each bottle and Rs-35 of each bottle. 2) Sale Proceeds of Rs.-75/- 3) Ten pieces of plastic glass, after preparing proper seizure list and arrested him. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Santosh Kewat (28yrs) S/O Amrit Kewat of Vill-Jeladih, PO- Sidhi, Ps- Joypur, Dist- Purulia and arrange for its investigation.
