I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that sri Mahadeb Goswami S/O Kalipada Goswami of Village- Palma, P.O- Palma - Panchara P.S.- Kenda, Dist - Purulia, has committed theft of Electricity U/S 135(1)(b) of the Electricity (Amendment) Act-2007.

It is mention that service connection effected against smt. Mayna Goswami w/o Mahadeb Goswami (having consumer ID - 242069710, Meter No B2361947

On dated 02.07.2019 at about 05:20 PM, Sri Swarnup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of sri Mahadeb Goswami, S/O- Kalipada Goswami of Village- Palma, P.O- Palma Panchara, P.S.- Kenda, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisely i.e. bypassing of energy meter by cutting incoming service wire.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and two piece of wire by which electrically directly flow to his house without energy registration in WBSEDCL energy meter. It was also found that he/she was using the following electrical equipments -

- 1) Two nos Fan 60 watt each
- 2) One no. 100 watt TV
- 3) one no. 160 watt refrigerator
- 4) 5 nos. LED Lamp 12 watt each.
