





The above name complainant begs to state as follows:


- That the complainant inherited some property from his mother situated at mouza Damda and others mouzas which is under P.S. Kenda and within the jurisdiction of this Ld. Court.
- R.S. plot no. 456 of mouza Damda under P.S. Kenda, Khatian no. 331, and have kept valuable articles therein, he for his job used to reside at Pokhari, P.O. Bhelai Pahari, P.S. M.G. Mango, Jamshedpur and time to time visit the mouza Damda and used to reside in the said residential house.
- 3) That on the date of occurrence i.e. on 26/05/2019 at about 10:30 Am the accused persons without any reason





whatsoever criminally trespassed in the house of the complainant by breaking open the door and have taken away valuable utensils and also have taken away about 20 Qntl. Paddy and also damaged the house causing loss of about Rs. 40,000/- to 50,000/-

- That the complainant hearing such incident rust to the place of occurrence and asked the accused persons not to do such illegal acts but the accused person s in a very riotous mood assaulted the complainant with fist and blows and abused him in filthy languages and also gave out that they will not allow the complainant to reside in the said house. The accused persons are still threatening the complainant by giving out that if the complainant dare of report the matter before anyone including the P.S. etc in that case they would take revenge when opportunity comes.
- 5) That out of fear the complainant not in a position to report the matter before the Local P.S. to report the matter. But when the witnesses who have also witnessed the incident and the local people asked the complainant to report the

matters before the local P.S. to prevent any further incident and accordingly the complainant thereafter report the matter to the local P.S. in writing.

That the complainant have lodged this complainant before the Office-in-charge of local P.S. and Superintendent of Police Purulia but no legal action yet been taken under the law. Hence, the complainant is compelled to file this complainant before the Ld. Court.

It is therefore, prayed that your honour may be pleased to sent the petition of complaint to the Officer-in-charge, Kenda P.S. for registering a specific case and for investigation treating the same as FIR under section 156(3) for investigation.
