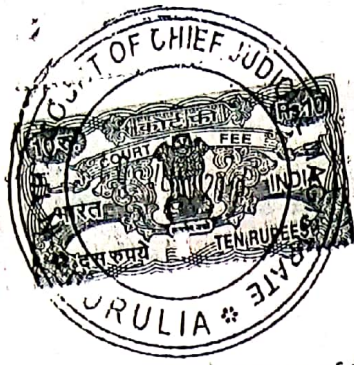

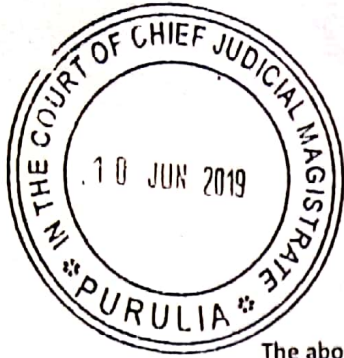

The above named petitioner begs to state as

follows.

1---That your complainant is a travelling agent and he used to go different villages of the locality to collect passengers for destinations of God and Godes in India by reserve buses .

2---That on the date of occurrence your complainant went to village Urusaram under Kotshila Police Station for collecting passengers and to meet with his friend Brindaban Das of Urusaram . After meeting his friend , your complainant was returning to his house at about 12.00/12.30 noon at that time with a pre-planned way the accused Indiram Mahato and his sister Domni Mahato kept a bullock Cart in cross direction on the Kuli Road near their house . The complainant politely requested the accused persons to remove the said Cart at this, accused Domni Mahato stated to quarrel with the Complainant and hurled filthy languages upon him .In the midst of quarrel accused Indiram Mahato , being abetted by his sister Domni Mahato , in order to finish the complainant from the world , started to assault him mercilessly by a Iron Rod on his head causing grievous bleeding injuries on the head of your complainant ^{and sketched P. 25/1912- from his hand} . When the complainant became senseless and seems to be dead .The accused persons presume that the complainant has died then they leave the place and hurriedly enter their house . After resuming his sense the complainant shouted for help then his friend Brindaban Das and other villagers took the complainant to Kotshila Police Station from where the complainant was sent to Kotshila Hospital where the Doctor stitched his wounds and treated him and seeing the gravity and critical condition of the complainant immediately referred him to Deben Mahato Sadar Hospital Purulia where the doctor admitted him as an indoor patient for 3 /4 days and discharged him from Hospital . After discharge and treatment from Hospital your petitioner lodged complaint against the accused persons in the local police station

3---That the complainant reported the incident to the local police who assured the complainant to take legal action against the accused persons but ultimately did nothing best known to them . Thereafter the complainant and his son approached the police and want to know about his complaint and came to learnt that the police is evasive in the matter and no specific case has been started against the accused persons till yet . Under such circumstances , your petitioner finding no other alternative but to knocked the door of the Superintendent of Police Purulia on 08/05/2019, but nothing has been done from his good office .

4---That your complainant is a poor man and acute distress and poverty . He is helpless in the matter . he is not in a position to pull and conduct the case on his own expenses. Moreover , there are some technical and legal aspects involved in this case like arrest , seizure which also requires considerable money and machinery , for all these , it is highly desirable that this case should be converted to a police case for through police investigation .
