I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Gour Bauri S/O Lt. Madhab Bauri of Village- Anandapur, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(b) of the Electricity (Amendment) Act-2007.

It is mention that service connection effected against Gour Bauri (having consumer ID - 201305959, Meter No RGG494143

On dated 18.07.2019 at about 02:15 pm I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Sri Gour Bauri S/O Lt. Madhab Bauri of Village- Anandapur, P.S.- Manbazar, Dist – Purulia and inspected his premises and found that he was enjoying electricity unauthorisely i.e. bypassing of energy meter by connecting another service cable from meter incoming terminal.

During inspection, theft of electricity was found, i.e., he was using electricity dishonestly U/S 135(1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and two piece of wire by which electrically directly flow to his house without energy registration in WBSEDCL energy meter. It was also found that he was using the following electrical equipments -

- 1) Three nos fan 60 watt each
- 2) Three nos LED lamp 9 watt each
- 3) One no 100 Watt TV
- 4) One no 100 watt bulb

out of which we seized the following -

- 1) One no 100 watt bulb
- 2) Two core PVC service cable (one feet approx)

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 02:30 pm on dated 18.07.2019 after disconnect the service line. The accused person has committed an offence U/S 135(1)(b) of the Electricity Act 2003, subsequently Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
