Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Kajal Gorain (28) S/O- Sadhu Gorain of Vill- Bhamuria, PS-Neturia, District- Purulia with seizure of 22 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list.

I beg to submit that today (02.07.19) at 19:15 hrs while myself along with force were performing anticrime mobile duty near Sarbari, received source information that one Kajal Gorain (28) S/O- Sadhu Gorain of Vill- Bhamuria, PS-Neturia, District- Purulia has illegally stocked liquor in his shop at Bhamuria village under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceeded to Bhamuria village to work out the information. At 19:35 hrs after reaching at Bhamuria village held raid in a shop of Kajal Gorain (28) S/O- Sadhu Gorain of Vill- Bhamuria, PS-Neturia, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his shop, on demand Kajal Gorain failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 22 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled the same. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Kajal Gorain (28) S/O- Sadhu Gorain of Vill- Bhamuria, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1) C/1140 Dayamoy Mahato and 2) C/1224 Gajan Murmu both of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Kajal Gorain (28) S/O- Sadhu Gorain of Vill- Bhamuria, PS-Neturia, District- Purulia under proper section of law.
