Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Kartick Paul (27) S/O- Santimoy Paul of Vill- Parbelia New Colony (Majhi Para), PS-Neturia, District- Purulia with seizure of 25 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list.

I beg to submit that today (03.07.19) at 18:45 hrs while myself along with force were performing anticrime mobile duty near Parbelia, received source information that one Kartick Paul (27) S/O- Santimoy Paul of Vill- Parbelia New Colony (Majhi Para), PS-Neturia, District- Purulia has illegally stocked liquor in his sweet shop at Parbelia New Colony (Majhi Para) under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Parbelia New Colony (Majhi Para) village to work out the information. At 19:05 hrs after reaching at Parbelia New Colony (Majhi Para) village held raid in a sweet shop of Kartick Paul (27) S/O- Santimoy Paul of Vill- Parbelia New Colony (Majhi Para), PS-Neturia, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his shop, on demand Kartick Paul failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 25 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled the same. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Kartick Paul (27) S/O- Santimoy Paul of Vill- Parbelia New Colony (Majhi Para), PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/382 Bipad Taran Chatterjee, (2) C/1001 Soumendu Das and (3) C/78 Utpal Sarkar all of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Kartick Paul (27) S/O- Santimoy Paul of Vill- Parbelia New Colony (Majhi Para), PS-Neturia, District- Purulia under proper section of law.
