In producing herewith one arrested accused namely Mithun Bal (26) S/O- Padmalochan Bal of Vill-Bhamal, PS- Nirsha, Dist- Dhanbad (Jharkhand) with one improvised country made pipe gun (iron made) approx 26 cm in length, steel colour butt, barrel, trigger, firing pin, hammer etc. along with 02 round live cartridge (marked as BMM KF) to the effect that today on 06.07.19 at 21:35 hrs while I, SI Kalyan Kumar Sakha along with force C/1224 Gajan Murmu & C/1140 Dayamoy Mahato were performing evening mobile duty vide Neturia PS CC No- 1472/19 Dt. 06.07.19 that time received a credible source information that one person is moving suspiciously at Chalmara (Sarbari - Panchet pitch road) under Neturia PS with an ill motive for committing any serious crime. Accordingly, I informed the matter to O/C Neturia PS and as per his kind order myself along with force who were engaged in evening mobile duty accompanied with me left for Chalmara to work out the information. I along with force reached at Chalmara under Neturia PS at about 22:05 hrs by Govt. vehicle. We found that on seeing police party, one person tried to flee away by riding on a motorcycle without registration number from there and after a hot chase we managed to apprehend him. On being asked he disclosed his identity as noted above. Searched the above noted person very carefully in presence of local people and recovered one improvised country made pipe gun (iron made) approx 26 cm in length, steel colour butt, barrel, trigger, firing pin, hammer etc. along with 02 round live cartridge (marked as BMM KF) from his exclusive possession, which was concealed in his waist and on being asked he stated incoherent statement in respect of his presence at the area at that time. There was every reasonable believe that the accused had came down in the area with a view to commit crime by using the illegal fire arms. On demand, he failed to produce any valid documents/license in respect of the said arms & ammunitions and the motorcycle. Accordingly, I seized and labeled in between 22:15 hrs to 22:35 hrs one improvised country made pipe gun (iron made) along with 02 round live cartridge (marked as BMM KF) and one motor cycle (Honda Shine) without number plate having Engine No- JC65E-12009925 & Chassis No- OME4JC65BAJT003610 from his possession under proper seizure list duly signed by the accused person and witnesses. I requested the available local people as witness during seizure but most of the people left the place but one namely Md. Khalil S/O- Lt. Abdul Hoque of Vill-Namodigha, PS-Neturia, Dist-Purulia signed as witness in seizure list and arrested the above noted accused person at 22:40 hrs after observing all the guidelines of Hon'ble Apex Court of India, Hon'ble High Court Calcutta, N.H.R.C & W.B.H.R.C.

Under the above fact and circumstances it is reasonably believe that arrested accused person have committed a serious offence and he is liable for an offence punishable U/S- 25/27 Arms Act & read with section 379/411 IPC.

Therefore, I pray that a specific case may kindly be registered against one Mithun Bal (26) S/O-Padmalochan Bal of Vill-Bhamal, PS- Nirsha, Dist- Dhanbad (Jharkhand) under proper section of law and arrange its investigation.
