I, Rukuya Devi W/o. Late Suresh Bhuia of Amdanga, P.S. - Neturia, Dist - Purulia beg to inform you that I am an old and destitute widow lady. On 28.06.2019 at about 2:00 pm. my neighbour (1) Sri Khakru Bhuia S/o. Gutka Bhuia and (2) Gutka Bhuia S/o. Late Badui Bhuia both of Amdanga, P.S. - Neturia, District - Purulia entered into my house forcibly by breaking main door and started to use filthy languages to me and while protest they started to assault me by fist and blows resulting as I myself and my two daughters sustained injury on our person. They also break down my T.V. Set and some table chairs and mischief those articles and at that time our neighbour Sri Sankar Paswan and Gulbi Devi when turned up they fled away from house.

So request you for taking legal action against those two persons after investigating the facts.
