Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Bistu Mondal (44) S/O- Manik Mondal of Vill-Gopalpur, PS-Neturia, District- Purulia with seizure of 21 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list.

I beg to submit that today (19.07.19) at 19:05 hrs while myself along with force were performing anticrime evening mobile duty near Sarbari more, received source information that one Bistu Mondal (44) S/O- Manik Mondal of Vill-Gopalpur, PS-Neturia, District- Purulia has illegally stocked liquor in his hotel at Jhanka More under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceeded to Jhanka More to work out the information. At 19.25 hrs after reaching at Jhanka More held raid in the hotel of Bistu Mondal (44) S/O- Manik Mondal of Vill-Gopalpur, PS-Neturia, District- Pura ia and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand Bistu Mondal failed to produce any valid document try authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 21 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and hande 1 a copy of the same to arrestee.

The arrested accd. namely Bistu Mondal (44) S/O- Manik Mondal of Vill-Gopalpur, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1) C/78 Utpal Sarkar, 2) C/66 Kameshwar Pandey and 3) C/1303 Biswanath Majhi all of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Bissa Mondal (44) S/O- Manik Mondal of Vill-Gopalpur, PS-Neturia, District-Purulia under proper section of law.
