Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Mangal Murmu (36) S/O- Jyotilal Murmu of Vill- Inanpur Majhi Para, PS-Neturia, District- Purulia with seizure of 22 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list.

I beg to submit that today (14.07.19) at 18:15 hrs while myself along with force were performing anticrime evening mobile duty near Sarbari More, received source information that one Mangal Murmu (36) S/O- Jyotilal Murmu of Vill- Inanpur Majhi Para, PS-Neturia, District-Purulia has illegal stock of liquor in his house at Vill-Inanpur Majhi Para under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceeded to Inanpur Majhi Para to work out the information. At 18:35 hrs after reaching at Inanpur Majhi Para held raid in the house of Mangal Murmu (36) S/O- Ivotilal Murmu of Vill- Inanpur Maihi Para, PS-Neturia, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Mangal Murmu failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 22 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled the same. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to the arrestee.

The arrested accd, namely Mangal Murmu (36) S/O- Jyotilal Murmu of Vill- Inanpur Majhi Para, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1140 Dayamoy Mahato (2) C/1224 Gajan Murmu and (3) C/1304 Dhananjoy Mondal all are of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Mangal Murmu (36) S/O- Jyotilal Murmu of Vill- Inanpur Majhi Para, PS-Neturia, District-Purulia under proper section of law.
