Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Ananda Baskey (42) S/O- Lt. Prabhu Baskey of Vill-Pahargora, PS-Neturia, District- Purulia with seizure of 23 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list.

I beg to submit that today (25.07.19) at 18:15 hrs while myself I, ASI Jhantu Dalal, with force were performing anticrime evening mobile duty near Jhanka more that time received a source information that one Ananda Baskey (42) S/O- Lt. Prabhu Baskey of Vill-Pahargora, PS-Neturia, District- Purulia has illegally stocked liquor in his tea shop at near Pahargora village under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction, I along with force proceeded to Pahargora village to work out the information. At 18.35 hrs after reaching at Pahargora held raid in the tea shop of Ananda Baskey (42) S/O- Lt. Prabhu Baskey of Vill-Pahargora, PS-Neturia, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his tea shop, on demand Ananda Baskey failed to produce any valid documents/License in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 23 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Ananda Baskey (42) S/O- Lt. Prabhu Baskey of Vill-Pahargora, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1) C/1001 Soumendu Das, 2) C/470 Somnath Nag and 3) C/1353 Atanu Ganguly all of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Ananda Baskey (42) S/O- Lt. Prabhu Baskey of Vill-Pahargora, PS-Neturia, District- Purulia under proper section of law.
