In producing herewith one arrested accd. person namely Bijoy Paswan (51 yrs) S/O Lt. Mundar Paswan of Vill - Bajkartar, PS- Para, Dist. Purulia with seized article i.e 23 (Twenty Three) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list.

I beg to submit that today (06.07.2019) during my Spl. raid duty in between 18.05 hrs to 18.45 hrs acting on a tip off a raid was conducted in the house of Bijoy Paswan (51 yrs) S/O Lt. Mundar Paswan of Vill - Bajkartar, PS- Para, Dist. Purulia and found that the above noted person was keeping and selling Country Spirit which were kept in his house. On demand he failed to produce any valid document in respect of keeping and selling of said liquors. As such I seized 23 (Twenty Three) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accd. person. During arrest maintain all rules and norms as well as guideline of NHRC/WBHCRC and also informed his family member.




