Sir,

In producing herewith one arrested accd. person namely Uttam Mandal (51 yrs) s/o Lt. Satish Mandal of Vill-Golkunda, PS- Purulia (M), District - Purulia with seizure list and seized articles.

I beg to submit that today (04.07.19) during mobile duty, acting of a secret source information and as per order of I/C Purulia (M) PS myself along with force had been to Kustaur more under PS Purulia (M) at 20:10 hrs. and as per indication conducted raid in the Maa Hotel of Uttam Mandal (51 yrs) s/o Lt. Satish Mandal at 20.15 hrs and found 2/3 persons fled way from his hotel and detained one person and asking his identity he disclosed his name address as noted above. On interrogation he confessed his guilty for selling and possession of foreign liquors styled as Officers choice/3x Rum, Beer and I.D liquor. On demand he failed to produce any valid document in respect of selling and possession of said of foreign liquors/ I.D. liquors at his Hotel. As such I seized 13 bottles of of foreign liquors styles as Officers choice containing 180 mls each, 13 bottles of foreign liquors styles as 3x Rum containing 180 mls each, 01 bottle of of foreign liquors styles as Officers choice containing 750 mls, four Bottles beer style as Kingfisher containing 650 mls each and, 01 ltr. I.D. liquor in a small jerician, 03 bottles taken from 31 bottles and one ltr. From jerician as samples under proper seizure list in presence of witnesses and signed by witnesses and accused person. Arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested accd. Namely Uttam Mandal (51 yrs) s/o Lt. Satish Mandal of Vill-Golkunda, PS- Purulia (M), District - Purulia committed offence u/s 46 (b) (d) B.E.Act. 1909 for unauthorized possession and sales of foreign liquor/ i.d liquor at his Hotel.

Under the fact and circumstance kindly take necessary lawful action against Uttam Mandal (51 yrs) s/o Lt. Satish Mandal of Vill-Golkunda, PS- Purulia (M), District - Purulia.
