That Dibakar Mishra used to create nuisance when ever I and my family members used to go to my village house. That the Dibakar Mishra & his brother Mritunjoy Mishra have high influence in local politics and are anti-social elements. That Dibakar Mishra uses slang and threatens me and my

That on 22.11.2018 Mr.Ajay Mahato informed me that the Dibakar Mishra & his wife along with his brother are making quarrel with him(Ajay Mahato) and his family members, also informed that Dibakar Mishra has developed latrine with two chambers in the open space of my house . That That Mr. Ajay Mahato informed that Dibakar Mishra has grabbed the entire open space and also entire paddy of mine. That Dibakar Mishra has demolished the chulah/cooking oven of my mother. That Dibakar Mishra and his brother Mr. Mritunjoy Mishra used to urine over the roof top of my house. That on objection the Dibakar Mishra and there anti-social friends used to threatens me. That on 24.11.2018 the Dibakar Mishra and his brother Mr. Mritunjoy Mishra made quarrel with my father (also assaulted him with shoe) . That the wife of Dibakar Mishra has beaten my father with shoe and Dibakar Mishra & Mritunjoy Mishra has beaten my father by fist. That dibakar Mishra & his wife on 24.11.2018 at about 04.40PM has beaten my father with shoe .

That after 24.11.2018 neither I nor any of my family member has entered the house. That on 15May 2019 my father died and the elder's of my village has given me written approval for conducting the last ceremony but Dibakar Mishra & Mritunjoy Mishra has disturbed the entire ceremony. That they have organized separate mundane ceremony and brahaman bhoj just to insult me and my deceased father.

It therefore prayed to you me-investigate and loge FIR against Dibakar Mishra, Mritunjoy Mishra and his wife.
