

The Complainant named above begs to state as follows:-


- 1) That the Complainant is the legally married wife of the Accused no-1 and their marriage was solemnized 19/06/2017 at the parental house of the Complainant at Pu ulia in accordance to the Hindu Laws of Marriage and the rites and custo ns prevailing in their society and after the marriage the Complainant went to her in-laws house at Golpahari, Jamshedpur, Jharkhand and the marriage tie still subsists.
- 2) That at the time of marriage, as per the demand of all the Accused Persons, the parents of the De-facto Complainant had to pay cash of Rupees Two




Lakhs, Gold and Silver Ornaments weighing 7 varies, Furniture, one Hero Honda Motor Cycle and other utensils towards the dowry.

- 3) That on the next day of the marriage i.e. on 20/06/2017 the Complainant went to her matrimonial house along with her husband with a new hope to start a new life with her husband and his family members and on that day the reception party was held at there. As per the rites and customs, the Complainant along with the Accused no-1 had been to her parental house at Purulia on 21/06/2017 and on the very night 'Fulsajjya' (Suhag Raat) was held and thus the marriage has been consummated after their physical union.
 - 4) That on 22 /06/2017 they returned to the house of the Accused no-1 but after reaching her in-laws house, the Complainant was being subjected to various sorts of insults and/or taunting by her husband and her in-laws and other inmates of their family alleging that the ornaments, furniture and other articles given by the parents of the Complainant were of lower standard and were not up to their satisfaction. They also expressed their dissatisfaction on the quantum of dowry amounting to Rupees Two Lakhs which was given to them at the time of marriage and since the very day, they started creating persistent torture upon the Complainant both physically and mentally, even they did not allow her to go to her parental house along with her husband to perform one of their customs 'Astahouse along with her mother-in-law i.e. the Accused no-3 clearly denied to the mother of the Complainant i.e. the Witness no-2 over telephone to perform such customs at Purulia and/or to send the new married couple to the parental house of the Complainant.
 - 5) That all the Accused Persons often used to pick up quarrel with the Complainant even on a negligible domestic affairs and often used to stop supplying adequate food and clothing to her. They also used to treat her as a maid servant. The Accused no-1 i.e. the husband of the Complainant used to work as an Employee in Tata-Tisco Company at Jamshedpur and he used to return to his house from his work in drunken condition and used to beat the Complainant. She with the hope of good life used to bear all such tortures.






- 6) That after 15 days of their marital life, the mother-in-law of the Complainant i.e. the Accused no-3 directed the mother of the Complainant i.e. the Witness no-2 over telephone to come to their house and to take her daughter with her to Purulia. In the middle part of the month of July, 2017, the mother and brother of the Complainant i.e. the Witness no-2 and 3 had been to her matrimonial house and at that time all the in-laws family members of the Complainant started abusing them with filthy languages and openly used to declare that they will arrange for the second marriage of the Accused no-1 as the Complainant is not up to their choice and is an ugly woman and for the purpose the Complainant will soon be driven out from the residence. Having found no other alternative the Complainant returned to her parental house along with her mother and elder brother.
 - 7) That after some days, the Accused no-1 being instigated by the other Accused Persons, demanded an additional dowry of Rs.1,00000/- (One Lakh) over telephone before the family members of the Complainant to which the parents of the Complainant expressed their inability to fulfill such further demand as the father of the Complainant is a retired person and is a bed ridden and is suffering from various ailments but all the Accused Persons constantly pressurised them to fulfill their such demand and clearly informed them that they did not accept the Complainant unless and until they paid further Rs. One Lakh to them.
 - 8) That being pressurized by them, in the month of October, 2017, the Witness no-2 to 4 took the Complainant to her matrimonial house with a sum of Rs.50000/- and on that day they paid Rs.50,000/- (Fifty Thousands)to the Accused Persons. Initially they did not agree to keep the Complainant to their house but after several requests made by the family members of the Complainant, they agreed to keep her to their house with a direction to pay the rest amount of 50,000/- as early as possible and also threatened them that if the rest quantum of the additional dowry be not paid to them, then she will be killed. The Complainant under the hope of good days in future used to tolerate all such tortures and ill treatments of her husband and his relatives.
 - 9) That such reunion of the Complainant with her husband did not last. The Complainant used to face inhuman torture by her husband and her in-laws



family members. The Complainant always used to perform her all duties towards her husband and his other family members like a Hindu devoted woman and also performed all the domestic works as per the instruction of her mother-in-law and other family members. The Accused no-1 always used to insult the Complainant by saying that she is an ugly woman and he would marry again with a beautiful and rich woman very soon.


- 10) That thereafter at the time of Rakhi Utsav i.e on 26/08/2018 the Complainant after so many requests was allowed to go to her parental house to observe the Rakhi Utsav and she along with the Witness no-3 i.e. her elder brother came to Purulia but surprisingly enough that on the very day at the evening the Accused no-1 came to Purulia at the parental house of the Complainant and without any reasons whatsoever pressurized her to leave the house immediately and to return back with him to her in-laws house. The family members of the Complainant requested him to stay in their house only for that night but the Accused no-1 did not pay any heed to the same and suddenly started to assault the Complainant by fist and blows in presence of all the family members of the Complainant. Having found no other alternative on that night the Complainant returned to her in-laws house along with the Accused no-1.
 - 11)That the Complainant used to bear all such tortures with a hope that good days will surely be come but all in vain. But before the time of Durga Puja, 2018 all the Accused Persons assaulted the Complainant mercilessly without any reason for which she sustained injury in her right eye and after getting information from the Complainant over phone all the other Witnesses had been to the matrimonial house of the Complainant and tried to console them but they did not pay any heed. All the Accused Persons became very much aggressive and started to abuse the family members of the Complainant with abusive languages and in a rowdy manner threatened them of dire consequences. The Accused no-1 at that time also clearly expressed his intention that he will arrange for his second marriage. The Accused no-3 snatched all her gold ornaments and garments and drove her out from their house and finding no other alternative the Complainant along with her family members came back to her parental house on the very day and since then she is residing there at the mercy of her poor



parents. She was also examined and treated by one Dr. Paramanik at Purulia for her injuries.

- 12) That presently all the Accused Persons over telephone constantly pressurizing the Complainant and her other family members to get their marriage dissolved through divorce for which the Opposite Party is under gross mental trauma and agony which tantamount to cruelty. Thereafter all the family members of the Complainant on several occasions had been to the house of the Accused no-1 to make him as well as his other family members agreed to accept the Complainant once again but for no good.
- 13) That thereafter the Complainant lodged a Written Complaint before Purulia(T)P.S. against the Petitioner and his other family members u/s 498A along with some other penal sections of IPC against the Petitioner and his other family members through Registered Post on 04/02/2019. Subsequently the police officer of concerned P.S. called the Complainant over telephone and accordingly the Complainant went to P.S. The police officer, on duty after hearing about the incident narrated by the Complainant, assured the Complainant and her companions that they will take appropriate steps and measures against the Accused Persons and on getting such assurance the Complainant, her father and others went back to their residence.
- 14) That be it mentioned here that one Domestic Violence Case has also been filed by the Complainant against the Accused Persons before the Protection Office, Purulia on 04/02/2019 and which is still pending in the Court of the Judicial Magistrate, 2nd Court, Purulia for trial and disposal vide Misc Case-46 of 2019. Subsequently the Complainant has served with one Notice of one Matrimonial Suit vide no-82/2019, pending in the Court of the Ld. Principal Judge, Family Court, Jamshedpur, filed by the Accused no-1 against the Complainant for Divorce on some false and baseless grounds and accordingly the Complainant has appeared in that case and is contesting the same.
- 15) That after waiting for a considerable period when the Complainant found that the police of Purulia(T)P.S. practically has not taken any step whatsoever against the Accused Persons, the Complainant on 02/05/2019





submitted a Written Complaint before the Superintendent of Police, Purulia but even in spite of all these endeavors of the Complainant, no step has been taken by the police and as such the Complainant is being compelled to lodge this Petition u/s 156(3) Cr.P.C. before Your Honour's Court.

- 16) That thus the Accused Persons have committed offences u/s 498A/323/506/34 IPC and u/s 3 and 4 D.P.Act with the Complainant and are liable to be prosecuted accordingly.
- 17) That the Complainant is a poor rustic woman and it is quite impossible for her to arrange for collecting evidences in this regard without the help of police machineries and it is also impossible for her to bear the cost of the case.

It is therefore prayed that Your Honour may be graciously pleased to send this Complaint to the O.C., Purulia(T). with a direction to investigate into the matter treating this Written Complaint as F.I.R.
