





The humble petition U/S 156 (3) of the Code of Criminal Procedure 1973 on behalf of the petitioner above named;


Most respectfully begs to state:

- 1. That the petitioner is legally married wife of the accused No. 1 which is still subsisting between them.
- 2. That the marriage of the petitioner with Soumen Rakshit was registered before the District Registrar -cum Marriage Officer, Purulia on 14/2/2011.
- 3. That prior to the marriage between the petitioner and the accused they used to practice "Taekwondo/ Karate" in same club and gradually fall in love with each other. Prior to the marriage the relation between the petitioner and her husband was known to the family members of the accused No. 1, like his father Aruan Rasshik (S/o Sudhangsu Rakshit), mother Mamta Raskhit(w/o Arun Rakshit), Brother Soumitra Rakshit (S/o Arun Rakshit), sister Supriya Raskhit (D/O Arun Raskhit) and wife of the bother namely Manisha Sao (w/o Somitra Raskhit) who used to




reside in the in-laws house of the petitioner situated at Hucukpara, New Colony (Mission Rode) within Purulia town P.S., District Purulia.

- 4. That the accused persons used to tell the petitioner not to disclose her relationship or marriage with Soumen to her parents or relatives, as they told that the parents and relatives of the petitioner would not accept our relation and advised her to disclose the same after the registration of marriage.
- 5. That the petitioner accordingly did not disclosed anybody about her marriage and after the registration of marriage the petitioner had requested her husband to took her to his house for numbers of times but he started deferring the matter on various pretexts .He used to tell that after his proper establishment and after making his carrier he would take her to his house.
- 6. That in the main time, in 2015, the petitioner went to Hallisahar, Kanchra Para and their the husband of the petitioner visited her and disclosed that he does not want to proceed with the marriage and asked her to arrange for the dissolution of marriage and forced her to proceed with the same, but again he raised protest.
- 7. That in the year 2017, the petitioner came back Purulia and tried to come in touch with Soumen but he started avoiding the petitioner and having no alternative she had disclosed the matter to her parents and relatives and they made several attempts to place herself in her in-laws house.
- 8. That on 25/09/2018 the petitioner went to the house of Soumen and in presence of Soumen and all of his family members, the petitioner had requested the accused persons to allow the petitioner to stay at their



house as legally marriage wife of Soumen to which each of the accused persons stated giving out various demand like Rs.10 lacks in cash, 12 Bhoris of Gold (ornaments), One Scorpio car for purpose of Soumen's business, Refrigerator, Almira, A.C and T.V sets, along with dressingtable and other furniture they also gave out that for placing such demand at the time of marriage, they had conspired to go for such marriage.

- 9. That on 26/09/2018 the petitioner along with her fathers and relatives went to house of the accused persons. On the very sight of them, all the accused persons stated telling when we would bring those articles and also gave out those dowry articles they would allow the petitioner to stay in their house otherwise they would arrange marriage of Soumen for the second time. Those accused person pushed the petitioner and her father out of the house and stating abusing them in filthy languages and also instigated petitioner to commit suicide. Having no other alternative they had to leave that place.
 - 10. The matter was reported to O.C. of Purulia within 28/09/2018 by a registered letter but till date no steps was taken though the police officials had assured to register a case. The matter was again reported to Superintendent of Police, Purulia on 1.4.2019, but no action was taken till date.
 - 11. That this case requires through investigation, examination of witnesses, collection of documents and accordingly there requires a regular police investigation.



It is, therefore, prayed that your Honour may graciously be pleased to direct the police of Purulia (Town) P.S to treat this petition as a F. I. R. and to cause investigation in respect of the alleged incident.

And for which act of kindness, your petitioner, as in duty bound shall ever pray.
