Sub: Accident by bus no. BRI6P0457 locally known as "PARTHA SARATHI"

Respected Sir,

I, the undersigned, would like to lodge this complaint to the effect that on 06/07/2019(Saturday), at around 6:00 p.m, while my mother was going towards cooks compound, within Purulia town, from Tikia Para, in a motorcycle with me. At that time, near BT Sarkar Road (District Library), a bus bearing no. BR16P0457, locally known as "PARTHA SARATHI", which was proceeding towards Purulia Bus stand and the driver of the said bus was driving the bus in a rash and negligent manner and in zig-zag fashion. In course of crossing the motor cycle the bus dashed my motor cycle and my mother namely Saroj Devi Sharma, wife of Subhas Chandra Sharma of Tikia Para, Purulia, fell down from the motor cycle and sustained grievous bleeding injury on her person. The said vehicle ran over upon the legs of my mother namely Saroj Devi Sharma and she was immediately taken to Purulia Sadar hospital, but seeing her serious condition, the attending doctor referred her BSMCH at Bankura at about 9 pm for her better treatment.

In course of transfer at around 10:30 pm, she succumbed to her injuries. The accident happened due to rash and negligent driving on the part of the driver of the bus bearing no. BR16P0457.

Myself, was proceeding with my motor cycle on the left side of the road and the bus turned to its right and caused the accident.

The matter was informed to your good office vide **Purulia Town U/D case no:- 230/19 dated 07/07/2019.**

The delay in lodging of the FIR is due to engage for treatment of my mother Saroj Devi Sharma, and thereafter for her rituals.

You are therefore requested to lodge a complaint against the wrong doer and do the needful in accordance with law.
