Sir,

I, the undersigned with due deference would like to apprise your good office that on 5th day of April, 2017, I and one of my sibling namely, Arup Kumar Goswami (my younger brother) entered into an agreement so prepared on certain terms and conditions specially towards amicable transfer of some joint routes of buses under our respective ownership to each other's exclusive name and favour and we put our signatures in all the pages of the document in question in present of the witnesses present and our signatures were duly identified before the said document being notarised. The document in question was put before one Mr. Binod Kumar Sao, Notary, Government of West Bengal (Purulia Sadar) and our respective photographs were duly affixed there at, ultimately the Notarial Certificate was issued. Pursuant to the said amicable settlement and terms of the agreement in question when I applied before the competent authority for getting the said transfer implemented I could gather from a Notice send to me by Mr. Sattwik Bhattacharyya, Advocate of Calcutta High Court, without any date in the said notice, on behalf of Arup Kumar Goswami that Arup Kumar Goswami submitted one document claiming the same to be the Deed of cancellation dated 03.04.2018 of aforementioned agreement dated 05.04.2017 allegedly containing my signature, too. The notice send to me by Mr. Sattwik Bhattacharyya was also attached with a copy of said alleged cancellation agreement. But I never had been to Mr. Binod Kumar Sao to execute such 'Cancellation Agreement' nor did I put my signature on any of such document.

It will not be out of place to mention here that the said alleged 'Cancellation Agreement' does not bear the signature of the alleged executants in all its pages, nor their photographs would be found there-from. That apart from the single side Xerox of a non-judicial paper the date of issuance of the same could not be procured.

It is pertinent to mention here that one Dwijapada Mahato, Ld. Advocate corroborating my claim / contention informed me in writing that he did not identify the alleged signature of mine that is of 'Mr. Aloke Kr. Goswami' as shown in the 'Cancellation Agreement' allegedly made on 03.04.2018. The register containing the signatures of the executants under the possession of said Mr. Bonod Kr. Sao, Notary, Govt. Of West Bengal (Purulia Sadar) will suffice.

Search and Seizure is highly warranted here to unearth the truth.

My brother said Sri Arup Kr. Goswami already is enjoying the profit from the joint routes having their respective Permit nos. (1) 6/1987 (IS) Purulia to Bokaro (2) 15/2005 (IS) Bokaro to Ghatshila (3) 4/2016 (IS) Tata to Hazaribag in which the buses having their respectively registration numbers 1) WB. 55A/4911, 2) WB. 55A/1604, 3) WB.55A/4411 are being run, though I alone being the sole owner of these buses have to bear the cost by way of depositing the instalments towards the repayment of the loan amount , moreover the profit so denied from the Saw Mill, namely 'SHAKTI SAW MILL', at Namo Para, Tulin, Purulia, under joint ownership of myself and said Sri. Arup Kr. Goswami is being deposited in an account the passbook and the cheque book of which are all along lying under the custody of said Arup. Kr. Goswami and in such a way I am being deprived off.

Not only that said Arup Kr. Goswami is also enjoying the entire profit and possession of the route having the permit no. 21/2014 Tulin to Purulia as well

as the bus having its registration no. WB.55/6015 both under my ownership. Moreover Arup Kr. Goswami is also enjoying the entire profit alone from the route having the permit no. 1/69, i.e. Tulin to Purulia via Suisa, and the bus having its registration no. WB.55/3735 both the route permit as well as the ownership of the bus is under my joint name and of Arup Kr. Goswami. Said Arup Kr. Goswami with a view to achieve and enjoy more wrongful gain fabricated and manufactured a forged document in the form of alleged 'Cancellation Agreement' as mentioned above intending that the document shall be used for the purpose of cheating and fraudulently and dishonesty used the same as prosecuted and punished.

It is required to be mentioned here that I have mentioned the informed the same matter before Bar Association, Purulia on 24.06.2019 for information and necessary action.

Such being the backdrop you are hereby requested to take necessary steps/action against the above named culprit by way of setting the law in motion for giving him a substantial lesson.
