Sir,  
with due respect I am informing you for taking action of the following facts which happened on 25.07.19 at Mani Baiji Lane, Kapargali, Purulia, at about 11.30 Am to 12 Am. The owner of glitter House Sri Nilmani Sen and his two Son namely Pappu Sen and Pintu Sen and other 3-4 person of that area whose names are not known to me suddenly attacked and leadly injured the left eye by blowing a punch.

The Cause of my presence on that spot was that I, the owner of xerox Centre i.e, Sayona xerox at N.L. Ghosh Street opposite Purujal National Bank occasionally goes there for servicing purpose of xerox printer in the company authorised service centre situated on the 1st floor of that Redimade garment shop. I went there in my motor cycle with Kalipada Singh S/o Daman Singh of Parka Bahad, Deshbendhu Road, Purulia for carrying the printer. I stand my motor cycle by the side of that Redimade shop as previously done. Kalipada was standing there beside the motor cycle and I went to the service centre. when I came back I heard the slang & filthy language of both Pappu & Pintu Sen for standing the motor cycle there. I asked Kalipada what happened? Then all on a sudden Pappu & Pintu Sen both S/o Nilmani Sen rushed to me and started beating mercilessly in my chest & back and face with those 3/4 ~~to~~ unknown persons. Pappu Sen snatched the printer and my mobile and thrown on the street, and Pintu Sen suddenly at that moment strike a heavy blow in my left eye for which I could not able to see any thing - only obscure and hazy vision. P.T.O.

I fell down on the street. Kalipada tried to resist but unable to chase. He collected the Printer & mobile phone of mine and rushed to my xerox counter for help of other staff. Hearing the incident from Kalipada my other staffs immediately rushed to the spot and rescued me, took me to Dr. A.T. Sengupta's chamber in front of my xerox counter. Dr. A.T. Sengupta is an eye specialist. Due to the heavy blow of punch I become extremely injured and become senseless.

there fore I could not remind the happenings further what my staff's were doing then. I also could not able to go to the hospital nor even the Police station at that very moment. what Dr. Sengupta advised me I accordingly followed that. He referred me to Disha Eye hospital at Barabek Pore, I went there and the treatment is going on. For the cause of my treatment of my eyes I could not able to inform you earlier.

Now please take necessary action against Pappu Sen & Pintu Sen s/o Nilmani Sen as early as possible.
