The undersigned with all humility place before your goodself the following matter of tactical deception/misappropriation of his legitimate fund and the factum of criminal breach of trust done by Alope Goswami, son of Late Shaktipada Goswami of Mahananda Chakraborty Lane, Munsifdanga, P.O. and District - Purulia for registering a specific case and to undertake proper investigation.

The undersigned is the youngest of the three brothers and his father, ~~Late~~ Late Shaktipada Goswami had left behind huge landed property both in Tulin and Purulia Town. He was owner of several Bus Route within the District and inter State, number of Buses, Saw Mill and one I-10 Honda Car.

That, after demise of Shaktipada Goswami there was joint sitting of the undersigned and Alope Goswami in presence of their eldest-brother. Asis Goswami in 2016 and in April, 2017 governing STA permit No.4/16 from Jamshedpur to Hazaribagh in which bus bearing No.WB-55A/4411 was in operation. Permit No.6/1987 from Purulia to Bokaro on which bus No.WB-55A/4911 was in-operation. All those interstate routes were in joint name of undersigned and Alope Goswami.

Alope Goswami was allthroughout is very much high-handed and arbitrary in his approach and he never felt to have confidence of the undersigned in management of tension and proper accounts from sale in those three routes.

The undersigned, had sought intervention of Bus Owners' Association and in presence of Sri Santa Mukherjee had presided over a sitting of the dispute in presence of other respected person.

Alope Goswami by passing all mutual decisions have conducting and plying busses in those 3 interstate routes which yield huge profit keeping the undersigned in dark and by misappropriating his share.

The undersigned as per talks of settlement and to place a new bus in Bokaro-Ghatshila route purchased a new Bus bearing Registration No.WB-55A/7462, but Alope <sup>Goswami</sup> ~~Samanta~~ with dishonest intention have committed criminal breach of trust by not allowing him to place the new bus for plying.

That, since middle of 2018, Alope <sup>Goswami</sup> ~~Somanta~~ have not informed the undersigned the total income in each of those three routes where the Route Permit is in joint name.

That, the minimum profit in each of those three routes wanted not be less than Rs.1,00,000/- per month and till date Alope <sup>Goswami</sup> ~~Somanta~~ have most dishonestly put the undersigned ~~to~~ wrongful loss and have criminally misappropriate at least Rs.12,00,000/- (Rupees Twelve Lakhs) only and have thereby caused wrongful gain for him.

That, the undersigned had arranged to ~~serve~~ serve a legal ultimatum through his legal spokesman to Alope Goswami on 2/7/19 urging him to do the needful within 15 days . However, Alope <sup>Goswami</sup> ~~Somanta~~ did not pay any heed to it.

Alope Goswami in order to cover up his misdeed have lodged a false complaint against the undersigned and two others on baseless allegations on 20.07.19 before Officer-in-Charge, Purulia(T) P.S.

That, the undersigned appealsto your goodself to treat this complaint as F.I.R. and embark on investigation to book the offender.
