

The Complainant above named begs to state as follows :-

1. That the Complainant and the accused persons are the residents of Village- Chakua, under P.S. Purulia(M) and within the jurisdiction of this Learned Court.
2. That on the date of occurrence i.e. on 31.01.2019 at about 12.30 P.M. all the accused persons forcibly

of the Complainant. Seeing this illegal activities of
the accused persons the Complainant raised objection, then
all the accused persons named above being armed with deadly
weapons, like~~s~~ Lathi, Tangi, Sword, Stones etc. in their
hands, forming unlawful assembly with common intention to
commit murder to the Complainant; They came and appeared
infront of the house of the Complainant and they started
to throw brick bates over the house of the Complainant
and as a result of which the windows of the Complainant
have broken down.

The Complainant protested against the illegal
activities of the accused persons, then all the accused
persons started to assault the Complainant by fists and
blows. Thereafter Accused Uttam Mahato forcibly snatched
away the ear rings from the ears of the Complainant and
as such the ears of the Complainant have torned and the
Complainant sustained bleeding injury on her ears. The
said Uttam Mahato also took away the said ear rings of
the Complainant. The Complainant sustained a loss of
Rs.6,000/- . The Complainant raised alarm by saying "Banchao,
Banchao",. Hearing the noises her son Rabindranath Mahato
came to the spot to save the Complainant from the hands
of the accused persons, then all the accused persons also
assaulted the said Rabindranath Mahato by fists and blows .
Thereafter seeing the witnessses the accused persons fled
away.

The witnesses named above saw the incident and the matter was also reported to them.

3. That thereafter the Complainant was shifted to the Sader Hospital, Purulia for her treatment and she admitted in this hospital as an indoor patient.
4. That the Complainant also reported the matter to the Officer-in-charge, Purulia (M) P.S. but Police of Purulia (M) P.S. did not take any steps against the accused persons. Thereafter the Complainant reported the matter to the Superintendent of Police, Purulia on 19.3.2019 but till now police did not take appropriate steps against the accused persons. So the Complainant has been compelled to take shelter before the Learned Court.
5. That the Complainant is a poor woman and there is a question of search and seizure which can not be done in a complaint basis case, So, for the ends of justice Police is required.

It is, therefore, prayed that your Honour may be graciously pleased to send this petition of Complaint to the Officer-in-Charge, Purulia (M) P.S., treating the same as F.I.R. and to investigate the same as provided Under Section 156(3)
