I Biplob Mahato S/o. Ashoke Kumar Mahato Advocate Purulia of village - Dhurahi P.O. - Gengana P.S. Purulia (W) Dist. Purulia beg to state that yesterday on 2-7-2019 at about 12:30 P.M. I started from my residence with my child, cousin brother in my car being Maruti Suzuki Alto 800 LXI bearing registration number WB56K 2596 with view to reach Asansol for my family work. When I was proceeding on road I found near a place about 1 or 1/2 K.M. from Jharukhaman under Raghunathpur police station. A big truck was coming behind me and the driver of the said truck very roughly and negligently driving dashed my car on the back side and caused heavy damage of the back side of my vehicle and my child Surja Mahato aged about 1 1/2 years on inside of his mouth. I became perplexed and mentally shocked. The said offending truck ran with a higher speed and fled away. I could learn that the said truck did accident to some person or side by shop.
