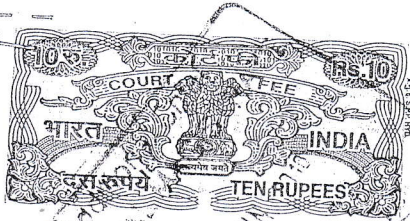

Complainant most respectfully showeth:-

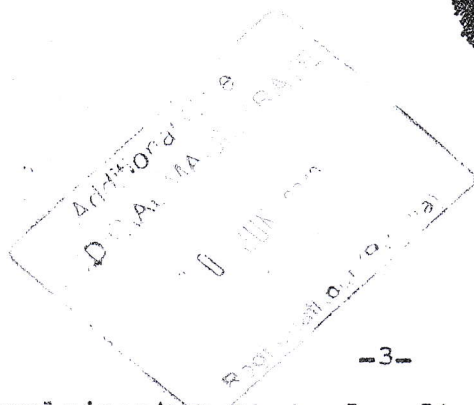
1. That the complainant and acced. persons are well known to each other.

2. That the acced. no. 1 to 4 are all time trying to do mischief with the persons and property of the complainant by the sheer of force.

3. That on the day of incident all the acced. persons in order to fulfill their common intention trespassed into the land of the complainant i.e. over R.S Plot no.1924 of mouza:Pabra(Desaha) which exclusive belongs to the complt. and his elder brother Bholanath Singh S/O Lt. Chhutu Singh and started cutting two matured palm tree(Tal) standing thereon which were sufficiently grown and under the nourishment of complainant and his brother. All the acced. person were armed with viz. Matukdhari, Sundar and their two other associates each had sharp big size Axe in their hand. And others two namely Ramprasad and Pahalan were armed with iron rod and Taala. At the relevant point of time complainant found the acced. persons to have cut down the said plam trees into seperate trunks and taking away the same, from the P.O. in which complainant raised protests but all the acced. persons became red teeth & claws and gave out "

Needless to say while complainant shouted against such illegal & overt act of the acced. persons then all of them desperately rushed to the complainant with deadly weapon and entered into his dwelling house with an intention to cause greivous injury to the persons or the complainant but complainant had a very narrow escape. Be it mentioned listed witnesses and many others have been the illegal & overt act of the acced. persons. That due to such offence

complainant sustained a financial loss worth Rupees:10,000/- Apart from that he also suffered mental trauma.

That complainant lodged a written complaint against the acced. persons with Raghunathpur P.S. on 07-05-19 ^{though} ~~not~~ ^{but} in vain thereafter complainant also sent his grievance to the S.P.Purulia through Regd. post on dtd.: 16-05-19 but till day no action has yet been taken, in the meantime acced. persons also threatened the complainant to face similar consequence as such being frighten finding no other alternative complainant seeks his remedy before the Ld. court.

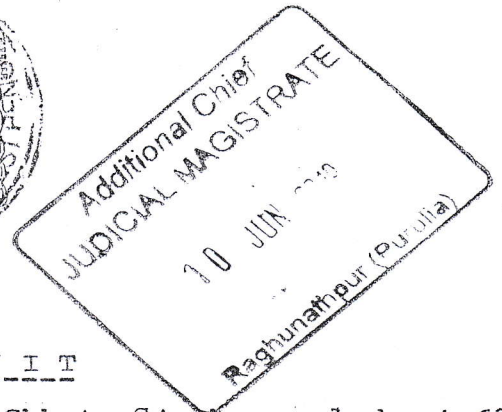
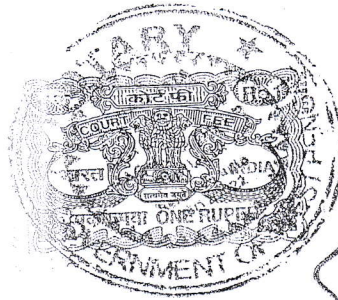
