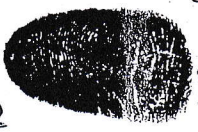

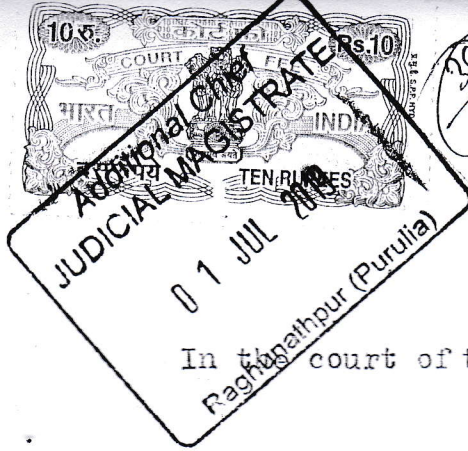

2. That your complainant is one of the beneficiary under the scheme of "PRADHAN MANTRI ABASH YOJANA" vide I/P No.:- WB3961483.

That under the said scheme complainant has been provided with some financial assistance by the appropriate authority and on that strength she started to renovate her old mud house into a concrete roof accordingly she stacked raw material viz. stone-chips 300 Cft. Brick-3000(nos.) and 3 wooden log in front of her old dwelling house for the purpose of construction and renovation of her old dwelling house.

That be it mentioned complainant and her family member left her house in the morning on 26-05-19 for her father's house at vill: Sankra , where she and her son, daughter-in-law stayed upto 27-05-19 night and on the following day she returned to her house and found that all the stuffs/articles have been stolen from the P.O. and ~~her house~~ on search complt. and her son found the stolen article under the custody of acced. Prakash Chakraborty on interogation Prakash Chakraborty flatly uttered to have taken away the article and he for the disclosed that nobody can do anything against his overt act.
