Sir,

In producing herewith one accused person namely Bijoy Gorai (38 Yrs.) S/o Nandalal Gorai of Vill.- Chelliyama, Mairapara, PS – Raghunathpur, Dist.- Purulia under arrest along with seized (1) 32 (Thirty Two) plastic bottles in sealed condition containing 600 ml Country Sprit in each bottles and labeled with "DILSE" on the outer side of the bottles and (2) One big size plastic bag.

I, SI Bangshi Badan Mondal of Raghunathpur PS beg to submit that today i.e. on 25.07.19 at about 20:05 hrs during my special evening mobile duty received a source information that the above noted accused person has been stocking & selling liquor illegally & clandestinely at his Food shop at Chelliyama Bazar under this PS. On receiving such information, I communicated the matter to IC Raghunathpur PS and as per his direction I along with force rushed to the spot to work out the said information. On arriving to the spot / PO at 20:25 hrs the above noted accused person was trying to flee away from his food shop but we managed to apprehended him there, but all the customers who were consuming liquor, seeing the Police party managed to escape and on searching found the above noted country sprits are kept in a corner of this food shop in concealing condition. On interrogation the apprehended person had disclosed his name & address as noted above. I asked him to produce documents / license in support of the said liquor but he failed to produce any papers / documents in support for stocking & selling such liquor. As such I seized the above noted articles after preparing proper seizure list and duly signed by the accompanying party and the labeled one bottle as sample file. After this I arrested the above noted accused person at 20:35 Hrs. after observing all the formalities as per law.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the arrested accused person namely Bijoy Gorai (38 Yrs.) S/o Nandalal Gorai of Vill.- Chelliyama, Mairapara, PS – Raghunathpur, Dist.- Purulia under proper section of law and arrange for its investigation.
