Entered the premises of Mriganka Sekhar Mondal S/o - Lt Nakul Mondal  
vill- Surisagra, P.O- Agulbari, P.S- Raghunathpur, Purulia having consumer

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by taping the incoming cable of the energy meter installed in the said premises and therefore bypassing the energy meter of W.B.S.E.D.C.L. i.e. U/S 135 (1)/(b) was detected.

From the above arrangement he/she was using the following electrical equipments
