Respected Sir,

In forwarding herewith the arrested accused Nazrul Ansary (36yrs), S/o - Inul Ansary of Vill. - Kanki Bazar, PS - Santaldih, Dist.- Purulia under arrest in custody with proper escort I beg to state that on 20/07/2019 at 16.35 hrs in course of patrolling duty SI Ramesh Chandra Hazra of Santaldih PS received a source information that a person was moving suspiciously on the Santaldih - Chelyama pitch road which was diarized vide Santaldih PS GDE No. 729, dated 20/07/2019. As per direction of IC, Santaldih PS, he moved to the spot immediately. On arrival of police party the person tried to flee away and pursuing hot chase the person was intercepted by police and after thorough search an improvised country made fire arms loaded with live ammunition were found. On asked he failed to produce any valid license or relevant documents in support of such possession. An improvised country made fire arms loaded with live ammunition has been seized from his exclusive possession. He disclosed his identity as Nazrul Ansary (36yrs), S/o - Inul Ansary of Vill. - Kanki Bazar, PS - Santaldih, Dist.- Purulia and he was arrested subsequently. On returned to PS SI Ramesh Chandra Hazra lodged a complaint against Najrul Ansary and the above noted case was started. As per direction of IC, Santaldih PS, myself took up the investigation of the case.

During investigation, I have visited the P.O., drawn rough sketch map of the P.O. with index, examined witnesses and recorded their statements U/S 161 Cr PC.

Therefore, I, pray, before your honour that accused Nazrul Ansary (36yrs), S/o - Inul Ansary of Vill. - Kanki Bazar, PS - Santaldih, Dist.- Purulia, may kindly be taken in J.C. and I strongly oppose his bail at this initial stage of investigation.
